## **MINUTES**

CITY OF HIALEAH GARDENS TUESDAY, SEPTEMBER 20, 2016 CITY COUNCIL CHAMBERS 10001 NW 87 AVENUE

- **1. Call to Order:** Chairman Garcia called the meeting to order at 7:30 p.m.
- **2. Roll Call:** Present were Chairman Luciano Garcia, Councilman Jorge Gutierrez, Councilman Jorge A. Merida and Councilman Elmo L. Urra. Also present were Mayor Yioset De La Cruz and City Attorney Charles A. Citrin. Councilman Rolando Piña was absent.
- **3. Invocation:** Chairman Garcia gave the invocation.
- 4. Pledge of Allegiance: Mayor De La Cruz led the Pledge of Allegiance.
- **5. Deletions / Emergency Additions:** None were offered.
- **6. Review of Minutes: September 6, 2016.** Chairman Garcia made a motion to approve the minutes of September 6, 2016 seconded by Councilman Merida. The motion was unanimously approved.
- **7. Public Comments:** None were offered.

# 8. Presentation of Proclamation to Mr. Jerry Rivero, CEO, The Jerry Rivero Fund for Amyotrophic Lateral Sclerosis (ALS).

Mayor De La Cruz took this opportunity to present a proclamation to Mr. Jerry Rivero, proclaiming September 20, 2016 as "The Jerry Rivero Fund Day" in the City of Hialeah Gardens. The Mayor made comments regarding the challenges this disease has presented to Jerry and all those that suffer from it. He congratulated Jerry for his strength and courage and for his efforts, through the Jerry Rivero Fund, in working to find a cure for ALS. A photo opportunity was provided at this time.

# 9. Proposed Resolutions:

A) RESOLUTION OF THE CITY OF HIALEAH GARDENS APPROVING AND RATIFYING THE AGREEMENT FOR THE CITY'S HEALTH INSURANCE BETWEEN AVMED AND THE CITY OF HIALEAH GARDENS; PROVIDING FOR SEVERABILITY; PROVIDING FOR CONFLICTS; PROVIDING FOR EFFECTIVE DATE.

Mr. Citrin read the full title of the resolution into the record. Ms. Aida Martinez-Ruiz, Director of Personnel, came forward and provided details of the proposals received by the City through its insurance broker, Millennium Benefits. AvMed the City's current provider presented a plan which remained competitive with an increase of 8% over last year's plan. Ms. Martinez-Ruiz also mentioned at this time that there would be no increase in the City's supplemental health insurance which is provided by Allstate. After a review of all proposals, Ms. Martinez-Ruiz recommended renewing the health and supplemental coverage with the current carriers. Representatives from Millennium Benefits were present to answer any questions. Chairman Garcia made a motion to approve, seconded by Councilman Merida. The motion was unanimously approved.

B) RESOLUTION OF THE CITY OF HIALEAH GARDENS APPROVING AND RATIFYING THE AGREEMENT FOR THE CITY'S SUPPLEMENTAL HEALTH INSURANCE BETWEEN ALL STATE INSURANCE AND THE CITY OF HIALEAH GARDENS; PROVIDING FOR SEVERABILITY; PROVIDING FOR CONFLICTS; PROVIDING FOR EFFECTIVE DATE.

Mr. Citrin read the full title of the resolution into the record. He mentioned that this is for the City's supplemental insurance which was discussed during the previous resolution. Chairman Garcia made a motion to approve, seconded by Councilman Merida. The motion was unanimously approved.

C) RESOLUTION OF THE CITY OF HIALEAH GARDENS, FLORIDA, APPROVING AND RATIFYING AN AGREEMENT FOR THE CITY'S LONG AND SHORT TERM DISABILITY AND LIFE INSURANCE BETWEEN CIGNA AND THE CITY OF HIALEAH GARDENS, PROVIDING FOR CONFLICTS, PROVIDING FOR SEVERABILITY AND PROVIDING FOR AN EFFECTIVE DATE.

Mr. Citrin read the full title of the resolution into the record. Ms. Martinez-Ruiz recommended renewing the City's long and short term disability and life insurance with Cigna as they had provided a two year guarantee for the same rate. Chairman Garcia made a motion to approve, seconded by Councilman Merida. The motion was unanimously approved.

a motion to approve, seconded by Councilman Merida. The motion was approved unanimously by individualized voice vote. **(4-0)**

- **13. Mayor's Report Miscellaneous –** Mayor De La Cruz thanked the Council for their continued. He expressed his appreciation to Chief Manuel Zardon for his work on the recent police contract with the PBA which was negotiated in record time and for the new leadership he has brought to the Department. The Mayor also thanked the department heads in attendance.
