## **MINUTES**

CITY OF HIALEAH GARDENS TUESDAY, JANUARY 20, 2015 CITY COUNCIL CHAMBERS 10001 NW 87 AVENUE

- **1.** Call to Order: Chairman Garcia called the meeting to order at 7:30 p.m.
- **2. Roll Call:** Present were Chairman Luciano Garcia, Councilman Jorge A. Merida, Councilman Elmo L. Urra, Councilman Jorge Gutierrez, and Mr. Charles A. Citrin, City Attorney. Councilman Rolando Piña and Mayor Yioset De La Cruz were absent.
- **3. Invocation:** Chairman Garcia gave the invocation.
- **4. Pledge of Allegiance:** Mr. Charles A. Citrin led the Pledge of Allegiance.
- **5. Deletions / Emergency Additions:** None were offered.
- **6. Review of Minutes: December 16, 2014.** Chairman Garcia made a motion to approve the minutes of December 16, 2014 seconded by Councilman Merida. The motion was unanimously approved.
- **7. Public Comments:** None were offered.

8. Request for approval of 2 COP alcohol beverage license for Sal y Pimienta Sabor Latino, LLC, 12533-35 W. Okeechobee Road, Hialeah Gardens, Florida, Owner: Ms. Ada Delafe.

Chairman Garcia read item eight into the record. The applicant Ms. Ada Delafe was present and came forward. Mr. Juan Rivera, O.M.B. Director came forward on behalf of Robert Lorenzo, License Director and gave staff recommendation for approval. At this time no one came forward to comment on the item. Chairman Garcia then made a motion to approve, seconded by Councilman Merida. The motion was unanimously approved.

At this time, Mr. Citrin mentioned that at the last Council Meeting the City Council asked Mr. Juan Rivera, O.M.B. Director to provide a third quote from a vendor for payroll services. Mr. Juan Rivera came forward and stated that he had received a quote from Intuit in the amount of \$31,000 which is still higher than Paycom. Chairman Garcia stated that they would therefore remain with the original decision of selecting Paycom.

A) RESOLUTION OF THE CITY OF HIALEAH GARDENS, FLORIDA, APPROVING THE ENTERING INTO AN INTERLOCAL AGREEMENT BETWEEN THE CITY OF HIALEAH GARDENS AND MIAMI-DADE COUNTY, FLORIDA IN SUBSTANTIALLY THE FORM AS ATTACHED HERETO AS EXHIBIT "A", RELATING TO THE COUNTY'S PROCUREMENT PROCEDURES WHEN IMPLEMENTING THE BUILDING BETTER **COMMUNITIES** BOND **PROGRAM** AND FURTHER AUTHORIZING THE MAYOR AND THE CITY CLERK, AS ATTESTING WITNESS, ON BEHALF OF THE CITY, TO ENTER INTO THE INTERLOCAL AGREEMENT AND TAKE ANY OTHER ACTION IN FURTHERANCE THEREOF; PROVIDING FOR CONFLICTS; AND PROVIDING FOR AN EFFECTIVE DATE.

Mr. Citrin read the full title of the resolution into the record. Mr. Juan Rivera, O.M.B. Director came forward and stated that this is an \$867,000 dollar bond that Miami Dade County had available for the city towards the construction of the main force of the NW district including the sewer. Chairman Garcia inquired as to how much of the \$867,000 was available, to which Mr. Rivera stated that it was the entire amount.
