MINUTES

CITY OF HIALEAH GARDENS TUESDAY, MARCH 17, 2015 CITY COUNCIL CHAMBERS 10001 NW 87 AVENUE

- **1.** Call to Order: Chairman Garcia called the meeting to order at 7:30 p.m.
- **2. Roll Call:** Present were Chairman Luciano Garcia, Councilman Jorge A. Merida, Councilman Elmo L. Urra, Councilman Jorge Gutierrez, Mr. Charles A. Citrin, City Attorney and Mayor Yioset De La Cruz. Councilman Rolando Piña was absent.
- **3. Invocation:** Chairman Garcia gave the invocation.
- **4. Pledge of Allegiance:** Mayor De La Cruz led the Pledge of Allegiance.
- **5. Deletions / Emergency Additions:** None were offered.
- **6. Review of Minutes: March 03, 2015.** Chairman Garcia made a motion to approve the minutes of March 03, 2015 seconded by Councilman Merida. The motion was unanimously approved.
- **7. Public Comments:** None were offered.

8. Proposed Resolution:

A) RESOLUTION OF THE CITY OF HIALEAH FLORIDA, AUTHORIZING THE CITY MAYOR TO ACCEPT THE EDWARD BYRNE MEMORIAL JUSTICE ASSISTANCE GRANT AWARDED FOR THE **PURPOSE** MAKING **RECORDS** IMPROVEMENTS BY PURCHASING LAPTOPS: PROVIDING CONFLICTS: PROVIDING FOR SEVERABILITY; PROVIDING FOR AN EFFECTIVE DATE.

Mr. Citrin read the full title of the resolution into the record. Chief Toth came forward and mentioned that this resolution serves to accept the Edward Byrne Grant. Chairman Garcia inquired about the amount of the grant, which Chief Toth stated that it was for \$4,200 dollars. In previous years the grant was administered by Miami-Dade County however, it is now FDLE who will be overseeing the grant and monitoring how the funds are being utilized. Chairman Garcia then made a motion to approve, seconded by Councilman Merida. The motion was unanimously approved.

He then made a motion to approve, seconded by Councilman Merida. The motion was unanimously approved by individualized voice vote. **(4-0)**

10. Second Reading / Public Hearing for consideration and final adoption of the following ordinance:

All conditions set by T.R.C. were met except for providing proof of existing dedications. Mr. Lopez stated that this condition is more of a County issue and therefore would like for the item to move forward. The architect of the project Mr. Alvin Cohen, on behalf of the applicant, came forward for the record. The applicant stated that he had no objections with all the conditions set forth by staff. Chairman Garcia then opened the public hearing at 7:44. No one came forward. He then closed at 7:44. He then made a motion to approve, seconded by Councilman Merida. The motion was approved unanimously. (4-0)

All board members from Planning and Zoning and Water and Sewer department were reappointed.
