MINUTES

CITY OF HIALEAH GARDENS TUESDAY, MARCH 18, 2014 CITY COUNCIL CHAMBERS 10001 NW 87 AVENUE

- **1. Call to Order:** Chairman Garcia called the meeting to order at 7:31 p.m.
- **2. Roll Call:** Present were Chairman Luciano Garcia, Councilman Jorge A. Merida and Councilman Elmo L. Urra. Also present were Mr. Charles A. Citrin, City Attorney and Mayor Yioset De La Cruz. Councilman Rolando Piña and Councilman Jorge Gutierrez were absent.
- **3. Invocation:** Chairman Garcia gave the invocation.
- **4. Pledge of Allegiance:** Mayor De La Cruz led the Pledge of Allegiance.
- **5. Deletions / Emergency Additions:** None were offered.
- **6. Review of Minutes: March 04, 2014.** Chairman Garcia made a motion to approve the minutes of March 04, 2014 seconded by Councilman Merida. The motion was unanimously approved.
- **7. Public Comments:** None were offered.

8. Request for approval of 2COP alcohol beverage license for Padel Corp. / Stop Restaurant DBA, 9101 West Okeechobee Road, Hialeah Gardens, FL: Owner: Mr. Ivan Pareta Delgado.

Chairman Garcia read item eight into the record. The applicant Ivan Pareta was present and came forward. Robert Lorenzo, License Director came forward and gave staff recommendation for approval. At this time no one came forward to comment on the item. Chairman Garcia then made a motion to approve, seconded by Councilman Merida. The motion was unanimously approved.

9. Proposed Resolutions:

A) RESOLUTION OF THE CITY OF HIALEAH GARDENS, FLORIDA AUTHORIZING THE EXTENSION OF THE FY2011 HOME CONTRACT BETWEEN MIAMI-DADE COUNTY AND THE CITY OF HIALEAH GARDENS FOR THE SAMARI LAKE EAST CONDOMINIUM REHABILITATION ASSISTANCE PROGRAM; PROVIDING FOR CONFLICTS; PROVIDING FOR SEVERABILITY; PROVIDING FOR EFFECTIVE DATE.

Mr. Citrin read the full title of the resolution into the record. At this time Mr. Jerry Bell came forward and stated that the City was allocated \$507,779.78 through its FY 2011 HOME contract with Miami-Dade County in order to implement the rehabilitation of eligible owner-occupied condominium units at the Samari Lake East condominiums. Mr. Bell mentioned that the City has successfully completed the rehabilitation of 16 units with the FY 2011 allocation, increasing the total number of units and households assisted under the program to 58. Mr. Bell went on to say that the City's contract with the County expired in 2013 and that a contract extension to June 2014 is necessary in order to allow the processing of remaining reimbursement requests and other administrative matters. The city has received new applications from Samari residents interested in the program, and Mr. Bell has requested additional recaptured HOME program funds in order to assist these units and also stated that the city will go after recaptured funds from the County. At this time no one came forward to comment on the item. Chairman Garcia then made a motion to approve, seconded by Councilman Merida. The motion was unanimously approved.

B) RESOLUTION OF THE CITY OF HIALEAH GARDENS, FLORIDA, AUTHORIZING THE ENTERING INTO AN AGREEMENT WITH COURTLY MANOR, LLC FOR THE PURPOSE OF COMPLETING CONSTRUCTION AND IMPROVEMENTS OF SANITARY SEWAGE FACILITIES; AUTHORIZING THE APPROPRIATE CITY OFFICIALS TO ENTER INTO AN AGREEMENT WITH COURTLY MANOR, LLC; PROVIDING FOR CONFLICTS; PROVIDING FOR SEVERABILITY; AND PROVIDING FOR AN EFFECTIVE DATE.

Mr. Citrin read the full title of the resolution into the record. Joe Lopez, Public Works Director came forward and gave details of the agreement between the City and Courtly Manor for the purpose of completing construction and improvements of sanitary sewage facilities. Mr. Lopez stated that it is funded through the capital improvement plan that the Council took action on a year and a half ago approximately. The money is in the bank, the plans are finalized and the permit is almost finalized as well. There is a preliminary construction budget of approximately 2.2 million which will construct a brand new package station which is a vacuum station and a sewage discharge station all in accordance with Miami-Dade County DERM. This job will get rid and take care of all the problems that the sewer system is causing all our residents within the subject property. The construction is scheduled for approximately a year and a half with the hopes of completing it in 10 months. Chairman Garcia then went on to ask if the 2.2 million was for the equipment to which Joe Lopez stated that the money was for the new sewer mains and the connection of the trailers to the system. The owners of the parcel are going to pay in accordance with the agreement, 150,000 to connect the system. The City will not lose its investment with redevelopment. At this time no one came forward to comment on the item. Chairman Garcia then made a motion to approve, seconded by Councilman Merida. The motion was unanimously approved.

C) RESOLUTION OF THE CITY OF HIALEAH GARDENS, FLORIDA, AUTHORIZING THE EXTENSION OF THE CITY'S CONTRACT FOR THE SENIOR CENTER'S CONGREGATE AND HOME DELIVERED NUTRITION PROGRAM WITH CONSTRUCTION CATERING, INC. FOR A PERIOD OF EIGHT MONTHS RETROACTIVELY TO NOVEMBER 1, 2013; PROVIDING FOR CONFLICTS; PROVIDING FOR SEVERABILITY; PROVIDING FOR AN EFFECTIVE DATE.

Mr. Citrin read the full title of the resolution into the record. Aida Martinez-Ruiz, Assistant City Attorney came forward for staff and gave details of extending the contract for the catering of meals at the senior center. It will be retroactive until Novemeber 2013 for eight months in order to go out for bid. Ms. Martinez-Ruiz also mentioned that the food catering company hasn't raised their prices in 3 years which is why the City has been extending the contract for an additional 2 years. At this time no one came forward to comment on the item. Chairman Garcia then made a motion to approve, seconded by Councilman Merida. The motion was unanimously approved.
