MINUTES

CITY OF HIALEAH GARDENS TUESDAY, SEPTEMBER 23, 2014 CITY COUNCIL CHAMBERS 10001 NW 87 AVENUE

- **1. Call to Order:** Chairman Garcia called the meeting to order at 7:34 p.m.
- 2. Roll Call: Present were Chairman Luciano Garcia, Councilman Rolando Piña, Councilman Jorge Gutierrez, Councilman Jorge A. Merida and Councilman Elmo L. Urra. Also present were Mayor Yioset De La Cruz and City Attorney Charles A. Citrin.
- **3. Invocation:** Chairman Garcia gave the invocation.
- 4. Pledge of Allegiance: Mayor De La Cruz led the Pledge of Allegiance.
- **5. Deletions / Emergency Additions:** None were offered.
- **6. Review of Minutes: September 9, 2014.** Chairman Garcia made a motion to approve the minutes of September 9, 2014 seconded by Councilman Merida. The motion was unanimously approved.
- **7. Public Comments:** None were offered.

8. Request for approval of 2COP alcohol beverage license for Fast Grill of Hialeah Gardens, Inc., DBA/ La Granja Pollos A La Brasa, 11870 Hialeah Gardens Boulevard, Hialeah Gardens, FL: Owner, Mr. Julio Martinez

The applicant Mr. Julio Martinez was present. Robert Lorenzo, License Director came forward and read the recommendation for approval of the 2 C.O.P. license Councilman Piña inquired if the applicant owned any other of La Granja restaurants, to which Mr. Martinez stated that he also owns the one located in the City of Hialeah. The applicant mentioned that the restaurant has the same menu as the other locations and offers both options to eat in or to take out. Based on staff recommendation Chairman Garcia made a motion to approve, seconded by Councilman Merida. The motion was approved unanimously.

Chairman Garcia stated that this was a first reading and as such an opportunity for public input would be provided upon second reading. Mr. Citrin read the full title of the ordinance into the record. Chairman Garcia opened the Public Hearing at 7:50 p.m. No comments were offered and the Public Hearing was closed at 7:50 p.m. Chairman Garcia made a motion to approve, seconded by Councilman Merida. The motion was approved unanimously by individualized voice vote. **(5-0)** Chairman Garcia congratulated Mayor De La Cruz as well as the staff for an excellent job preparing the budget and for the management of the City throughout the year that has put the City in an excellent financial situation. As a result the City is able to provide more services, capital improvement projects, and yet is still able to have twice the capital reserves that most the municipalities have in case of an emergency and not increase taxes.

- 13. Mayor's Report Miscellaneous Mayor De La Cruz briefly spoke about the highlights for this year's budget. Mayor De La Cruz stated that currently the City has 4.2 million dollars in the bank which is the same amount the City has kept since the year 2000. Revenues have increased and expenses have been trimmed back. The millage rate went down from 5.38 to 5.16 its lowest since 1984. Private investments are estimated this year at about 140 million dollars which is 20 millions dollars more than we had last year and is one of the largest amounts in the history of the City. Mayor De La Cruz thanked Mr. Juan Rivera, O.M.B. Director and staff for all the help and support with the budget and mentioned that the City is in a great financial state and its residents are enjoying one of the lowest millage rates in the history of the City.
