MINUTES

CITY OF HIALEAH GARDENS TUESDAY, NOVEMBER 18, 2014 CITY COUNCIL CHAMBERS 10001 NW 87 AVENUE

- 1. Call to Order: Chairman Garcia called the meeting to order at 7:32 p.m.
- **2. Roll Call:** Present were Chairman Luciano Garcia, Councilman Jorge A. Merida, Councilman Jorge Gutierrez, Councilman Rolando Piña, Councilman Elmo L. Urra, and Mr. Charles A. Citrin, City Attorney. Mayor Yioset De La Cruz was absent.
- **3. Invocation:** Chairman Garcia gave the invocation.
- **4. Pledge of Allegiance:** Mr. Charles A. Citrin led the Pledge of Allegiance.
- **5. Deletions / Emergency Additions:** None were offered.
- **6. Review of Minutes: November 04, 2014.** Chairman Garcia made a motion to approve the minutes of November 04, 2014 seconded by Councilman Merida. The motion was unanimously approved.
- **7. Public Comments:** None were offered.

8. Proposed Resolutions:

A) RESOLUTION OF THE CITY OF HIALEAH GARDENS, FLORIDA, AUTHORIZING THE ENTERING INTO A LEASE AGREEMENT WITH MANNY DIAZ JR., FOR RENTAL OF OFFICE SPACE IN THE HIALEAH GARDENS CITY HALL; AUTHORIZING THE APPROPRIATE CITY OFFICIALS TO ENTER INTO AN AGREEMENT WITH REPRESENTATIVE DIAZ; PROVIDING FOR CONFLICTS; PROVIDING FOR SEVERABILITY; AND PROVIDING FOR AN EFFECTIVE DATE.

Mr. Citrin read the full title of the resolution into the record. Chairman Garcia stated that Representative Diaz has been a very strong advocate of the City. Chairman Garcia welcomed State Representative Diaz to the City and looked forward to having his district office located in the City Hall. Chairman Garcia then made a motion to approve, seconded by Councilman Merida. The motion was unanimously approved.

B) RESOLUTION OF THE CITY OF HIALEAH GARDENS, FLORIDA, MEMORIALIZING THE AUTHORIZATION OF ENTERING INTO AN AGREEMENT WITH THE FLORIDA DEPARTMENT OF **TRANSPORTATION GRANTING** TEMPORARY EASEMENT FOR THE PURPOSE OF REPLACING FOUR (4) PARKING SPACES AND A PORTION OF THE CITY HALL MAIN ENTRANCE WITH SIDEWALK AND ROADWAY PAVEMENT FOR THE NW 87TH AVENUE WIDENING; AUTHORIZING THE EXECUTION OF SUCH AGREEMENT BY THE MAYOR; RATIFYING THE PROVISIONS OF SUCH AGREEMENT; PROVIDING FOR CONFLICTS; PROVIDING FOR SEVERABILITY; AND PROVIDING FOR AN EFFECTIVE DATE.

Mr. Citrin mentioned that items B, C, and D on the agenda were items that were previously discussed and voted on at the previous council meeting. Mr. Citrin then read the full title of the resolution into the record. Chairman Garcia stated that once again that these items had been previously addressed with Mr. Joe Lopez, Public Works Director and this resolution serves to memorialize council's action. Chairman Garcia then made a motion to approve, seconded by Councilman Merida. The motion was unanimously approved.

C) RESOLUTION OF THE CITY OF HIALEAH GARDENS, FLORIDA, MEMORIALIZING THE AUTHORIZATION OF ENTERING INTO A LEASE AGREEMENT WITH THE FLORIDA DEPARTMENT OF TRANSPORTATION (FDOT) FOR PARCEL 3931 FOR RECREATIONAL AMENITIES; AUTHORIZING THE APPROPRIATE CITY OFFICIALS TO ENTER INTO AN AGREEMENT WITH FDOT; PROVIDING FOR CONFLICTS;

PROVIDING FOR SEVERABILITY; AND PROVIDING FOR AN EFFECTIVE DATE.

Mr. Citrin read the full title of the resolution into the record. Chairman Garcia stated that this resolution serves to memorialize action taken at the previous council meeting. Chairman Garcia then made a motion to approve, seconded by Councilman Merida. The motion was unanimously approved.

Mr. Citrin read the full title of the resolution into the record. Chairman Garcia stated that this resolution serves to memorialize action taken at the previous council meeting. Chairman Garcia then made a motion to approve, seconded by Councilman Merida. The motion was unanimously approved.

OKEECHOBEE ROAD, SUITES 115-116, HIALEAH GARDENS, FLORIDA, TO PERMIT THE SALE OF ALCOHOLIC BEVERAGES 2COP (WINE AND BEER) TO BE CONSUMED ON THE PREMISES; PROVIDING FOR CONDITIONS, PROVIDING FOR EFFECTIVE DATE (TRC Vote: 5-0; P&Z Vote 3-0)

Mr. Citrin read the full title of the ordinance into the record. Chairman Garcia mentioned that Councilman Urra is off the dais at 7:37 p.m. At this time the applicant Adolfo Benitez-Garcia came forward. Chairman Garcia stated that this was a first reading and as such an opportunity for public input would be provided on second reading. He then made a motion to approve, seconded by Councilman Merida. The motion was approved unanimously with Councilman Urra off the dais. **(4-0)**

SAID LANDS LYING AND BEING IN THE CITY OF HIALEAH GARDENS, MIAMI-DADE COUNTY, FLORIDA, AND CONTAINING 87,350 SQUARE FEET OR 2.005 ACRES, MORE OR LESS; FOLIOS #: 27-2019-001-0050, 27-2019-001-0063, 27-2019-001-0062, 27-2019-001-0061, 27-2019-27-2019-001-0070.; PROVIDING 001-0060 and CONDITIONS, PROVIDING FOR AN EFFECTIVE DATE. (TRC Vote: 4-0; P&Z Vote n/a)

Mr. Citrin swore in all those who would be providing testimony on items for Second Reading / Public Hearing and proceeded to read the full title of the ordinance into the record. The applicant Mike Troxell with Thomas Engineering was present and came forward. Mr. Rey Regalado, Building Director then came forward on behalf of Joe Lopez, Public Works Director and Mirtha Gonzalez, Chief Zoning Official, who were unable to attend. Mr. Regalado referred to Mrs. Gonzalez's memo recommending approval as conditions by T.R.C. and Zoning had been met. He went on to read Mr. Lopez's memo which stated the following conditions: The Public Works Department owns and operates an existing retention area over and cross the subject right-of-way; The Department, however, supports the vacation with the following condition...The developer at his cost shall relocate the existing retention area including all the necessary plans, calculations, and approvals. The road closing petition, if approved, should be held in escrow into such time as said conditions are met. Chairman Garcia wanted to confirm that that there is no need for this road or for right of way. The applicant Mr. Troxell stated that he agrees with all the conditions and mentioned that the right of way is currently being used as a covenant overtop for the derm permit for the road throughout the whole NW area. Mr. Troxell said that what they are doing is dedicating an easement over top of the pond to relocate the storm water area from the right of way that currently exist to overtop of a portion of our storm water retention pond and Mr. Lopez is reviewing this as well as Derm. Mr. Troxell also mentioned that they need to execute a covenant with Miami-Dade County to relocate that which they're in full agreement to do. Mr. Regalado stated that prior to the first permit with the County all the conditions must be met. Chairman Garcia then opened the public hearing at 7:46. No one came forward. He then closed at 7:46. He then made a motion to approve, seconded by Councilman Merida. The motion was approved unanimously with Councilman Urra off the dais. (4-0)
