CITY OF HIALEAH GARDENS TUESDAY, JANUARY 22, 2013 CITY COUNCIL CHAMBERS 10001 NW 87 AVENUE

- **1. Call to Order:** Chairman Garcia called the meeting to order at 7:32 p.m.
- **2. Roll Call:** Present were Chairman Luciano Garcia, Councilman Jorge A. Merida, Councilman Jorge Gutierrez, and Councilman Elmo L. Urra. Also present were Mr. Charles A. Citrin, City Attorney and Mayor Yioset De La Cruz. Councilman Rolando Piña was absent.
- **3. Invocation:** Chairman Garcia gave the invocation.
- **4. Pledge of Allegiance:** Mayor De La Cruz led the Pledge of Allegiance.
- **5. Deletions / Emergency Additions:** Request for authorization to refinance 2010 Transportation Bond: Mr. Marcos Piloto, O.M.B. Director, was added to the agenda as Item 9D.
- **6. Review of Minutes: December 18, 2012.** Chairman Garcia made a motion to approve the minutes of December 18, 2012 seconded by Councilman Merida. The motion was unanimously approved.

7. Public Comments: None were offered.

8. Proposed Resolution:

A) RESOLUTION OF THE CITY OF HIALEAH GARDENS, FLORIDA DECLARING THE ACQUISITION OF PARCEL ONE REQUIRED **FOR** THE WIDENING IMPROVEMENT OF N.W. 102ND AVENUE WITHIN THE CITY LIMITS TO BE NECESSARY FOR A PUBLIC PURPOSE: AND AUTHORIZING SETTLEMENT WITH THE FEE SIMPLE TITLE HOLDER OF PARCEL ONE BY CONSENT FINAL JUDGMENT IN EMINENT DOMAIN COURT PROCEEDINGS; PROVIDING FOR CONFLICTS; PROVIDING FOR SEVERABILITY; AND PROVIDING FOR AN EFFECTIVE DATE.

Mr. Citrin read the full title of the resolution into the record. The item being discussed is related to a parcel which the city needed to acquire in order to serve the annexed area. A final consent judgement in eminent domain was negotiated between the City and the Dunn family. Mr. Citrin introduced Mr. Jeff Cynamon, Attoney who was present and worked with him on the negotiation. Mr. Citrin added that the Mayor and Joe Lopez, Public Works Director also played a role in s negotiations which ultimately has resulted in a savings to the City. Chairman Garcia made a motion to approve, seconded by Councilman Merida. The motion was unanimously approved.

Chairman Garcia stated that this was a first reading and as such an opportunity for public input would be provided on second reading. He then made a motion to approve, seconded by Councilman Merida. The motion was unanimously approved by individualized voice vote. (4-0)

9D. Request for Authorization to refinance 2010 **Discussion Item: Transportation Bond:** Mr. Marcos Piloto, O.M.B. Director.

Mr. Marcos Piloto, O.M.B. Director came forward and stated request more time to review analysis sheet and see if it would be feasible to move forward. The approval by the council will allow the city to lock a rate for 30 days. Mr Cintrin commended Mr. Piloto for his hard work on this issue. With no objection the council is instructing staff to go forward and prepare the ordinance for first reading on the next meeting. Chairman Garcia made a motion to approve, seconded by Councilman Merida. The motion was unanimously approved.

- 10. City Attorney's Report: Mr. Citrin congratulated the Mayor and Council Members that were unopposed for this election.
- 11. Mayor's Report – Miscellaneous: No comments.
