MINUTES

CITY OF HIALEAH GARDENS TUESDAY, FEBRUARY 5, 2013 CITY COUNCIL CHAMBERS 10001 NW 87 AVENUE

- **1. Call to Order:** Chairman Garcia called the meeting to order at 7:31 p.m.
- **2. Roll Call:** Present were Chairman Luciano Garcia, Councilman Rolando Piña, Councilman Jorge A. Merida, Councilman Elmo L. Urra and Councilman Jorge Gutierrez. Also present were Mr. Charles A. Citrin, City Attorney, and Mayor Yioset De La Cruz.
- **3. Invocation:** Chairman Garcia gave the invocation.
- **4. Pledge of Allegiance:** Mayor De La Cruz led the Pledge of Allegiance.
- **5. Deletions / Emergency Additions:** Request for authorization to refinance 2010 Transportation Bond: Mr. Marcos Piloto, O.M.B. Director, was added to the agenda as Item 9B.
- **6. Review of Minutes: January 22, 2012.** Chairman Garcia made a motion to approve the minutes of January 22, 2012 seconded by Councilman Merida. The motion was unanimously approved.

- **7. Public Comments:** None were offered.
- **8. Presentation: Students Working Against Tobacco (SWAT):** Ms. Rachelle Theodore, Miami Dade County Health Department.

Ms. Rachelle Theodore SWAT coordinator for the Miami Dade County Health Department came forward and gave details of the organization which has over 300 members and has been conducting presentations at numerous municipalities. Ms. Katherine Fuentes a student and member of the group came forward and gave a presentation to the council which detailed the dangers of the sale of flavored tobacacco to minors. Chairman Garcia applauded the students for their actions and the city welcomes the opportunity to review and pass a resolution on behalf of their efforts.

9. First Reading for consideration of the following ordinances:

A) ORDINANCE OF THE CITY OF HIALEAH GARDENS, FLORIDA, APPROVING A WAIVER OF PLAT OR TENTATIVE PLAT FOR TEBA SUBDIVISION. LEGAL DESCRIPTION: THE NORTH ONE HALF (N 1/2) OF TRACT 62 OF FLORIDA FRUIT LANDS COMPANY SUBDIVISION, IN SECTION 19, TOWNSHIP 52 SOUTH, RANGE 40 EAST, ACCORDING TO THE PLAT THEREOF, RECORDED IN PLAT BOOK 2, AT PAGE 17 OF THE PUBLIC RECORDS OF MIAMI-DADE COUNTY, FLORIDA APPROXIMATE LOCATION: BETWEEN THEORETICAL NW 109 AVENUE AND NW 112 AVENUE AND SOUTH SIDE OF NW 144th STREET, HIALEAH GARDENS, FL. FOLIO: 27-2019-001-0695; PROVIDING FOR CONDITIONS; PROVIDING FOR EFFECTIVE DATE.

Mr. Citrin read the full title of the ordinance into the record. Mr. Abraham Haddad with the surveying firm preparing the plat came forward. Chairman Garcia stated that this was a first reading and as such an opportunity for public input would be provided on second reading. He then made a motion to approve, seconded by Councilman Merida. The motion was unanimously approved. (5-0)

B) ORDINANCE OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF HIALEAH GARDENS, FLORIDA AUTHORIZING THE ISSUANCE OF NOT EXCEEDING \$2,120,000 OF TRANSPORTATION TAX REFUNDING REVENUE BONDS OF THE CITY OF HIALEAH GARDENS, FLORIDA; PROVIDING FOR A SUPPLEMENTAL RESOLUTION SETTING FORTH THE DETAILS OF SAID BONDS; AND PROVIDING AN EFFECTIVE DATE.

Mr. Citrin read the full title of the ordinance into the record. Mr. Marcos Piloto Director of OMB came forward and read his memo into the record. The memo detailed the proposal from TD Bank for the refinancing of the 2010 Transportation Bond. The analysis of the proposal supports refunding the existing loan with TD Bank, which would provide the city with savings over the remaining debt payments of approximately \$96,175.00 after cost of issuance. Chairman Garcia stated that this was a first reading and as such an opportunity for public input would be provided on second reading. He then made a motion to approve, seconded by Councilman Merida. The motion was unanimously approved. **(5-0)**

Mrs. Mirtha Gonzalez Chief Zoning Official came forward and gave staff recommendation for approval of the site plan with conditions having been met. Chairman Garcia opened the Public Hearing at 7:46 p.m. No comments were offered and the Public Hearing was closed at 7:46 p.m.Chairman Garcia then made a motion to approve, seconded by Councilman Merida. The motion was unanimously approved. **(5-0)**
