MINUTES

CITY OF HIALEAH GARDENS TUESDAY, FEBRUARY 19, 2013 CITY COUNCIL CHAMBERS 10001 NW 87 AVENUE

- **1. Call to Order:** Chairman Garcia called the meeting to order at 7:32 p.m.
- **2. Roll Call:** Present were Chairman Luciano Garcia, Councilman Jorge A. Merida, Councilman Elmo L. Urra and Councilman Jorge Gutierrez. Also present were Mr. Charles A. Citrin, City Attorney, and Mayor Yioset De La Cruz. Councilman Rolando Piña was absent.
- **3. Invocation:** Chairman Garcia gave the invocation.
- **4. Pledge of Allegiance:** Mayor De La Cruz led the Pledge of Allegiance.
- 5. Deletions / Emergency Additions: None were offered.
- **6. Review of Minutes: February 5, 2013.** Chairman Garcia made a motion to approve the minutes of February 5, 2013 seconded by Councilman Merida. The motion was unanimously approved.
- **7. Public Comments:** None were offered.

Mr.Citrin stated that Item 10B should be moved up on the agenda and addressed following Item 8A.

8. Proposed Resolutions:

A) RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF HIALEAH GARDENS, FLORIDA URGING LOCAL RETAILERS SELLING TOBACCO PRODUCTS TO REFRAIN FROM SELLING AND MARKETING FLAVORED TOBACCO PRODUCTS BECAUSE SUCH PRODUCTS TEND TO PROMOTE AND INFLUENCE TOBACCO USE BY MINORS AND YOUNG ADULTS.

Mr. Citrin read the full title of the resolution into the record. This item was presented at the previous Council Meeting by Students Working Against Tobacco (SWAT) and serves to memorialize the organization's request for a resolution. Chairman Garcia made a motion to approve, seconded by Councilman Merida. The motion was unanimously approved.

10. Second Reading / Public Hearing for consideration and final adoption of the following ordinance:

B) ORDINANCE OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF HIALEAH GARDENS, FLORIDA AUTHORIZING THE ISSUANCE OF NOT EXCEEDING \$2,120,000 OF TRANSPORTATION TAX REFUNDING REVENUE BONDS OF THE CITY OF HIALEAH GARDENS, FLORIDA; PROVIDING FOR A SUPPLEMENTAL RESOLUTION SETTING FORTH THE DETAILS OF SAID BONDS; AND PROVIDING AN EFFECTIVE DATE.

Mr. Citrin swore in all those who would be testifying and read the full title of the resolution into the record. Mr. Marcos Piloto, O.M.B. Director came forward and stated that they have been able to negotiate the documents into its final form. Mr. Piloto mentions how the City will be saving over \$90,000 over the life of the loan with the refinancing of the Transportation Tax Bond at a lower interest rate. Chairman Garcia opened the Public Hearing at 7:35 p.m. No comments were offered and the Public Hearing was closed at 7:35 p.m. Chairman Garcia then made a motion to approve, seconded by Councilman Merida. The motion was unanimously approved by individualized voice vote. **(4-0)**

8. Proposed Resolutions:

B) RESOLUTION OF THE CITY OF HIALEAH GARDENS, FLORIDA, AUTHORIZING THE ENTERING INTO A LEASE AGREEMENT WITH EDUARDO "EDDY" GONZALEZ FOR RENTAL OF OFFICE SPACE IN THE HIALEAH GARDENS CITY HALL; AUTHORIZING THE APPROPRIATE CITY OFFICIALS TO ENTER INTO AN AGREEMENT WITH REPRESENTATIVE GONZALEZ; PROVIDING FOR CONFLICTS; PROVIDING FOR SEVERABILITY; AND PROVIDING FOR AN EFFECTIVE DATE.

Mr. Citrin read the full title of the resolution into the record. Chairman Garcia mentioned that this was just simply organizing a lease agreement between the city and representative Gonzalez for office space in the Hialeah Gardens city hall. Chairman Garcia then made a motion to approve, seconded by Councilman Merida. The motion was unanimously approved.

C) RESOLUTION OF THE CITY OF HIALEAH GARDENS, FLORIDA, AUTHORIZING THE ENTERING INTO AN AGREEMENT WITH DOUGLAS ZAMORA FOR THE PURPOSE OF COORDINATING SPECIAL EVENTS; AUTHORIZING THE APPROPRIATE CITY OFFICIALS TO ENTER INTO AN AGREEMENT WITH MR. ZAMORA; PROVIDING FOR CONFLICTS; PROVIDING FOR SEVERABILITY; AND PROVIDING FOR AN EFFECTIVE DATE.

Mr. Citrin read the full title of the resolution into the record. Chairman Garcia states that this item is for professional services to be provided for the city, and Mr. Zamora will be working closely with the city and handling special events. Chairman Garcia mentions the agreement is for one year, and it can always be revisited after the year to see if it needs to be renewed. Mr. Citrin then briefly states that there is a 30 day termination period, and that it doesn't necessarily have to go a whole year. Chairman Garcia then made a motion to approve, seconded by Councilman Merida. The motion was unanimously approved.

TRANSPORTATION TAX REVENUE BONDS, SERIES 2004 AND FINANCED THE COSTS OF ROAD IMPROVEMENTS WITHIN THE CITY AND RELATED ARCHITECTURAL, ENGINEERING, ENVIRONMENTAL, LEGAL AND OTHER PLANNING COSTS, AND (II) PAYING COSTS OF ISSUANCE OF THE BONDS; PROVIDING SECURITY FOR THE BONDS, PRESCRIBING THE FORM, TERMS AND DETAILS OF THE BONDS; AWARDING THE BONDS TO TD BANK, N.A. BY NEGOTIATED SALE; DESIGNATING THE BONDS AS "QUALIFIED TAX-EXEMPT OBLIGATIONS" WITHIN THE MEANING OF SECTION 265(b)(3) OF THE INTERNAL REVENUE CODE OF 1986, AS AMENDED: MAKING **CERTAIN** COVENANTS AGREEMENTS IN CONNECTION THEREWITH; AUTHORIZING THE OFFICE OF MANAGEMENT AND BUDGET DIRECTOR TO ADOPT TAX-EXEMPT BOND COMPLIANCE PROCEDURES PURSUANT TO CURRENT GUIDELINES OF THE INTERNAL REVENUE SERVICE, WHICH WILL APPLY TO THE BONDS AND TO THE CITY'S TAX-ADVANTAGED BONDS CURRENTLY OUTSTANDING AND HEREAFTER ISSUED; REPEALING ALL RESOLUTIONS OR PARTS OF RESOLUTIONS IN CONFLICT **PROVIDING** HEREWITH: FOR SEVERABILITY: PROVIDING FOR AN EFFECTIVE DATE.

Mr. Citrin read the full title of the resolution into the record. Chairman Garcia stated that this item goes hand in hand with ordinance 10B which was just approved. With no further comments Chairman Garcia made a motion to approve, seconded by Councilman Merida. The motion was unanimously approved.

Mr. Citrin read the full title of the ordinance into the record. Mr. Felix Pardo for the applicant was present. Chairman Garcia stated that this was a first reading and as

such an opportunity for public input would be provided on second reading. He then made a motion to approve, seconded by Councilman Merida. The motion was unanimously approved by individualized voice vote. **(4-0)**

Chairman Garcia opened the Public Hearing at 7:46 p.m. No comments were offered and the Public Hearing was closed at 7:46 p.m. Chairman Garcia then made a motion to approve, seconded by Councilman Merida.
