## **MINUTES**

CITY OF HIALEAH GARDENS TUESDAY, AUGUST 20, 2013 CITY COUNCIL CHAMBERS 10001 NW 87 AVENUE

- **1. Call to Order:** Chairman Garcia called the meeting to order at 7:35 p.m.
- **2. Roll Call:** Present were Chairman Luciano Garcia, Councilman Elmo L. Urra, Councilman Jorge A. Merida, and City Attorney Charles A. Citrin. Councilman Jorge Gutierrez, Councilman Rolando Piña, and Mayor Yioset De La Cruz were absent.
- **3. Invocation:** Chairman Garcia gave the invocation.
- **4. Pledge of Allegiance:** Mr. Citrin led the Pledge of Allegiance.
- **5. Deletions / Emergency Additions:** None were offered.
- **6. Review of Minutes: August 6, 2013.** Chairman Garcia made a motion to approve the minutes of August 6, 2013 seconded by Councilman Merida. The motion was unanimously approved.
- **7. Public Comments:** None were offered.

**8. Presentation of Audit Report FY11-12:** Mr. Nestor Caballero, CPA, Alberni Caballero & Company.

Mr. Nestor Caballero, CPA, came forward to present the audit report and financial statements for FY year ending September 30, 2012.. Mr. Caballero gave a brief summary of the report which included assests, liabilities, statement of activities, and capital projects and noted that the city was once again in good financial standing.

# 9. Proposed Resolution:

Mr. Citrin read the full title of the ordinance into the record. Mr. Citrin mentioned that there had been a change from 60 days to a 6 month moratorium. Mr Cintrin also stated that at this moment we do not have any clinics in the city.
