MINUTES

CITY OF HIALEAH GARDENS TUESDAY, SEPTEMBER 17, 2013 CITY COUNCIL CHAMBERS 10001 NW 87 AVENUE

- **1. Call to Order:** Chairman Garcia called the meeting to order at 7:32 p.m.
- **2. Roll Call:** Present were Chairman Luciano Garcia, Councilman Jorge Gutierrez, Councilman Jorge A. Merida and Councilman Elmo L. Urra. Also present were Mayor Yioset De La Cruz and City Attorney Charles A. Citrin. Councilman Rolando Piña was absent.
- **3. Invocation:** Chairman Garcia gave the invocation.
- **4. Pledge of Allegiance:** Mayor De La Cruz led the Pledge of Allegiance.
- **5. Deletions / Emergency Additions:** None were offered.
- **6. Review of Minutes: September 04, 2013.** Chairman Garcia made a motion to approve the minutes of September 04, 2013 seconded by Councilman Merida. The motion was unanimously approved.
- **7. Public Comments:** None were offered.

8. Proposed Resolutions:

A) RESOLUTION OF THE CITY OF HIALEAH GARDENS APPROVING THE COLLECTIVE BARGAINING AGREEMENT BETWEEN THE CITY OF HIALEAH GARDENS AND THE POLICE BENEVOLENT ASSOCIATION BEGINNING OCTOBER 1, 2013 UNTIL SEPTEMBER 30, 2016; PROVIDING FOR IMPLEMENTATION OF SUCH CONTRACT; PROVIDING FOR EFFECTIVE DATE.

Mr. Citrin read the full title of the resolution into the record. Assistant City Attorney Aida Martinez-Ruiz came forward and informed that the representatives of the PBA and the city had worked amicably resulting in a good three year contract. Chairman Garcia then made a motion to approve, seconded by Councilman Merida. The motion was unanimously approved.

B) RESOLUTION OF THE CITY OF HIALEAH GARDENS APPROVING AND RATIFYING THE AGREEMENT FOR THE CITY'S HEALTH INSURANCE BETWEEN COVENTRY HEALTH CARE PLAN AND THE CITY OF HIALEAH GARDENS; PROVIDING FOR SEVERABILITY; PROVIDING FOR CONFLICTS; PROVIDING FOR EFFECTIVE DATE.

Mr. Citrin read the full title of the resolution into the record. Assistant City Attorney Aida Martinez-Ruiz came forward and gave details of the city's health insurance and the supplemental health insurance. The city covers 100% of the employees. Ms. Martinez-Ruiz stated that there is an increase of 12.9% this year with the current provider. The only way to lower the premium cost would be to lower the benefits. Numerous companies' policies and rates were reviewed and Coventry was the most competitive even with the added increase. The city will be keeping the exact same coverage. Mayor De La Cruz stated that 3% of the increase was due to a tax on insurance companies which in turn was passed along to the city as a fee. The 12.9% is stil being negotiated at this time and Coventry added that they will be giving a \$10,000 credit to be used toward the premiums. Chairman Garcia then made a motion to approve, seconded by Councilman Merida. The motion was unanimously approved.

C) RESOLUTION OF THE CITY OF HIALEAH GARDENS APPROVING AND RATIFYING THE AGREEMENT FOR THE CITY'S SUPPLEMENTAL HEALTH INSURANCE BETWEEN ALL STATE INSURANCE AND THE CITY OF HIALEAH GARDENS; PROVIDING FOR SEVERABILITY; PROVIDING FOR CONFLICTS; PROVIDING FOR EFFECTIVE DATE.

Mr. Citrin read the full title of the resolution into the record. Assistant City Attorney Aida Martinez-Ruiz came forward and mentioned that she had covered this item in her previous statements and that the Chairman Garcia made a motion to approve, seconded by Councilman Merida. The motion was unanimously approved.

Mr. Citrin read the full title of the resolution into the record. Mayor De La Cruz mentioned that Commissioner Diaz was sponsoring a parade to commemorate Vietnam veterans and that the city will be offering their support. Chairman Garcia made a motion to approve, seconded by Councilman Merida. The motion was unanimously approved.

A) ORDINANCE OF THE CITY OF HIALEAH GARDENS, MIAMI-DADE COUNTY, FLORIDA, AMENDING THE OFFICIAL ZONING MAP OF THE CITY OF HIALEAH GARDENS APPROVING THE REZONING OF 5 +-APPROXIMATE LOCATED AT NW CORNER OF NW 114 STREET AND NW 92 AVENUE, HIALEAH GARDENS, FL., FROM TOWNHOUSE RESIDENTIAL ZONING USE DISTRICT (R-TH/12 DU/ACRE) TO MULTI-FAMILY RESIDENTIAL (R-M1/14.5DU/ACRE). FOLIO #: 27-2033-001-0290: DECLARING THIS ZONING MAP AMENDED TO CONSISTENT WITH THE COMPREHENSIVE PLAN OF THE HIALEAH **GARDENS PROVIDING** CITY OF FOR SEVERABILITY, PROVIDING FOR AN EFFECTIVE DATE. Mr. Cintrin swore in those individuals who would be giving testimony on items for Second Reading / Public Hearing. Mr. Citrin then read the full title of the ordinance into the record. The applicant Shahin Etessam came forward for the applicant. Mrs. Mirtha Gonzalez, Chief Zoning Official came forward and gave staff recommendations and read her memo into the record. The Central District is experiencing demand for medium density residential designation, especially in the

surrounding school area. This property has in the south and west boundaries developments with a density of 14 and 15 dwelling units per acre. Staff recommends that the city amend the zoning map to change the destination of the property from R-TH to RM-1, allowing the increae of density just up to 14.5 du/acre in order to be compatible with existing densities in the south Kasalta Villas and Garden Villas Condo II and west side Etheral Gardens I. TRC recommended the zoning change (5-0), and P&Z recommended the approval (3-0). Chairman Garcia then opened the Public Hearing at 7:44 p.m. No comments were offered and the Public Hearing was closed at 7:44 p.m. Chairman Garcia then made a motion to approve, seconded by Councilman Merida. The motion was unanimously approved by individualized voice vote. **(4-0)**

Mr. Citrin read the full title of the ordinance into the record. The applicant Shahin Etessam came forward for the applicant. Mrs. Mirtha Gonzalez, Chief Zoning Official came forward and gave staff recommendation for approval of the site plan. This is the same property which was previously rezoned and will be developed as a residential rental development of six (6) apartment two story buildings with 72 units in a site of 4.94 acres with 184 regular parking spaces and 6 handicap parking spaces. The property has been platted. There are no variances and all conditions were addressed. Chairman Garcia then opened the Public Hearing at 7:48 p.m. No comments were offered and the Public Hearing was closed at 7:48 p.m. Chairman

Garcia then made a motion to approve, seconded by Councilman Merida. The motion was unanimously approved by individualized voice vote. **(4-0)**

Mayor De La Cruz had stated at the last meeting that the Cty would be opting out of the DROP program as the program would not be feasible for the . Chairman Garcia then opened the Public Hearing at 7:49 p.m. No comments were offered and the Public Hearing was closed at 7:49 p.m. Chairman Garcia then made a motion to approve, seconded by Councilman Merida. The motion was unanimously approved by individualized voice vote. **(4-0)**

Mr. Citrin read the full title of the ordinance into the record. Mrs. Mirtha Gonzalez, Chief Zoning Official came forward and mentioned that the text amendments had been transmitted to the Department of Economic Opportunity and the letter responding had no comments or objections. There was also a letter from South Florida Planning Council which also stated that all was consistent with the strategic regional policy plan for South Florida. Chairman Garcia then opened the Public Hearing at 7:51 p.m. No comments were offered and the Public Hearing was closed at 7:51 p.m. Chairman Garcia then made a motion to approve, seconded by Councilman Merida. The motion was unanimously approved by individualized voice vote. **(4-0)**
