CITY OF HIALEAH GARDENS TUESDAY, February 21, 2012 CITY COUNCIL CHAMBERS 10001 NW 87 AVENUE

- **1.** Call to Order: Chairman Garcia called the meeting to order at 7:33 p.m.
- **2. Roll Call:** Present were Chairman Luciano Garcia, Councilman Jorge Gutierrez, Councilman Jorge A. Merida and Councilman Elmo L. Urra. Also present were Mr. Charles A. Citrin, City Attorney and Mayor Yioset De La Cruz. Councilman Rolando Piña was absent.
- **3. Invocation:** Chairman Garcia gave the invocation.
- **4. Pledge of Allegiance:** Mayor De La Cruz led the Pledge of Allegiance.
- **5. Deletions / Emergency Additions:** None were offered.
- **6. Review of Minutes: February 7, 2012.** Chairman Garcia made a motion to approve the minutes of February 7, 2012 seconded by Councilman Merida. The motion was unanimously approved.
- **7. Public Comments:** None were offered.

8. Proposed Resolutions:

A) RESOLUTION OF THE CITY OF HIALEAH GARDENS. RATIFYING AND AUTHORIZING **EXPENDITURE** OF \$8,000.00 FROM POLICE FORFEITURE FUNDS FOR THE PURPOSE OF SUPPORTING AND **FACILITATING** THE **NEW** ACCREDITATION PROCESS FOR THE HIALEAH GARDENS POLICE DEPARTMENT: WAIVING COMPETITIVE **BIDDING**; **PROVIDING FOR** CONFLICTS: PROVIDING FOR SEVERABILITY: AND PROVIDING FOR AN EFFECTIVE DATE

Mr. Citrin read the full title of the resolution into the record. Chief Toth came forward and gave details of the expenditure of forfeiture funds. A resolution will be prepared to authorize entering into an agreement with the Commission for Florida Law Enforcement Accreditation, Inc. Chairman Garcia made a motion to approve, seconded by Councilman Merida. The motion was unanimously approved.
