MINUTES

CITY OF HIALEAH GARDENS TUESDAY, April 3, 2012 CITY COUNCIL CHAMBERS 10001 NW 87 AVENUE

- **1. Call to Order:** Chairman Garcia called the meeting to order at 7:35 p.m.
- **2. Roll Call:** Present were Chairman Luciano Garcia, Councilman Rolando Piña, Councilman Jorge Gutierrez, Councilman Jorge A. Merida and Councilman Elmo L. Urra. Also present was Ms. Aida Martinez Ruiz, Assistant City Attorney serving as counsel for tonight's meeting. Mayor Yioset De La Cruz and City Attorney Charles A. Citrin were absent.
- **3. Invocation:** Chairman Garcia gave the invocation.
- **4. Pledge of Allegiance:** Councilman Piña led the Pledge of Allegiance.
- 5. Deletions / Emergency Additions: None were offered.
- **6. Review of Minutes: March 6, 2012.** Chairman Garcia made a motion to approve the minutes of March 6, 2012 seconded by Councilman Merida. The motion was unanimously approved.
- **7. Public Comments:** None were offered.

8. Request for approval of transfer of 2COP and 1APS alcohol beverage licenses for USA Truck Service Plaza, Inc. 9101 W. Okeechobee Road, Hialeah Gardens, FL. Owner: Mr. Giovanny Muñoz Hernandez.

Owner Giovanny Muñoz Hernandez was present. Robert Lorenzo stated that the city and staff in conjunction with the police department recommend that the city council transfer the 2COP and 1APS Dual Liquor license from the previous owner to USA Truck Service Plaza, Inc. In addition, the staff recommends that the new owners be encouraged to review the city code of Ordinances Chapter 10, and all the restrictions of the 2COP and 1APS license to avoid any violations. Based on staff recommendation, Chairman Garcia made a motion to approve, seconded by Councilman Merida. The motion was approved unanimously.

9. Discussion of proposals received for Qualified Banking Services for Utility System Revenue Note, Series 2012 (RFP 2012-01): Mr. Marcos Piloto, O.M.B. Director.

Mr. Marcos Piloto, O.M.B. Director came forward and reported that the City had advertised requests for financing proposals for a "Bank Qualified" loan in an amount not to exceed \$4,100,000 to fund City-wide improvements in accordane with the Water & Sewer Department's Five Year Capital Improvement Plan. Proposals were received from four banks, Pinnacle Public Finance, Regions Bank, TD Bank and SunTrust Bank. City staff in conjunction with the City's financial advisor, First Southwest Company analyzed all proposals and recommended TD Bank which provided the best interest rate and flexibility to prepay the loan without penalty at the lowest costs. Chairman Garcia made a motion to approve the recommendation, seconded by Councilman Merida. The motion was unanimously approved. Instructions were given to drat an ordinance to this effect for the next council meeting.

10. Second Reading / Public Hearing for consideration and final adoption of the following ordinance:
