#### **MINUTES**

CITY OF HIALEAH GARDENS TUESDAY, NOVEMBER 6, 2012 CITY COUNCIL CHAMBERS 10001 NW 87 AVENUE

- **1. Call to Order:** Chairman Garcia called the meeting to order at 7:34 p.m.
- **2. Roll Call:** Present were Chairman Luciano Garcia, Councilman Rolando Piña, Councilman Jorge A. Merida, Councilman Jorge Gutierrez and Councilman Elmo L. Urra. Also present was Mr. Charles A. Citrin, City Attorney. Mayor Yioset De La Cruz was absent.
- **3. Invocation:** Chairman Garcia gave the invocation.
- **4. Pledge of Allegiance:** Councilman Piña led the Pledge of Allegiance.
- 5. **Deletions / Emergency Additions:** There were none.
- **6. Review of Minutes: October 16, 2012.** Chairman Garcia made a motion to approve the minutes of October 16, 2012 seconded by Councilman Merida. The motion was unanimously approved.
- **7. Public Comments:** None were offered.

## 8. First Reading for consideration of the following ordinance:

Chairman Garcia opened the public hearing at 7:45 p.m. No one came forward; he therefore closed the public hearing at 7:45 p.m. and made a motion to approve, seconded by Councilman Merida. The motion was unanimously approved by individualized voice vote. **(5-0)** 

B) ORDINANCE OF THE MAYOR AND THE CITY COUNCIL OF CITY OF HIALEAH GARDENS, FLORIDA, AUTHORIZING THE EXTENSION OF THE EXCLUSIVE FRANCHISE WITH WASTE MANAGEMENT FOR THE PURPOSE OF TRASH AND GARBAGE SERVICES OF THE CITY OF HIALEAH GARDENS AND COLLECTION OF RECYCLABLE MATERIALS; PROVIDING FOR CONFLICTS; **PROVIDING** SEVERABILITY; PROVIDING FOR EFFECTIVE DATE.

Mr. Citrin recused himself from this item as he represents Waste Management. Ms. Aida Martinez-Ruiz came to the dais and read the full title of the ordinance into the record. Mr. Alex Gonzalez for Waste Management came forward and briefly stated that Waste Management has worked well with the City for a number of years and this ordinance provided an extension of the current contract. Chairman Garcia commented favorably about the responsiveness of Waste Management and their continued sponsorship of many of the City's events benefitting the City and its residents. He then opened the public hearing at 7:49 p.m. No one came forward; therefore Chairman Garcia closed the public hearing at 7:49 p.m. and made a motion to approve seconded by Councilman Merida. The motion was unanimously approved by individualized voice vote. **(5-0)**

- **11.** Mayor's Report Miscellaneous The Mayor was absent.
