## **MINUTES**

CITY OF HIALEAH GARDENS TUESDAY, JANUARY 4, 2011 CITY COUNCIL CHAMBERS 10001 NW 87 AVENUE

- 1. Call to Order: Chairman Garcia called the meeting to order at 7:30 p.m.
- 2. Roll Call: Present were Chairman Luciano Garcia, Councilman Elmo L. Urra, and Jorge A. Merida. Also present were City Attorney Charles A. Citrin and Mayor Yioset De La Cruz. Councilman Jorge Gutierrez and Councilman Rolando Piña were absent.
- **3. Invocation:** Chairman Garcia gave the invocation.
- **4. Pledge of Allegiance:** Mayor De La Cruz led the Pledge of Allegiance.
- **5. Deletions / Emergency Additions:** None were offered.
- **6. Review of Minutes:** November 16, 2010 Chairman Garcia made a motion to approve the minutes of November 16, 2010, seconded by Councilman Merida. The motion was unanimously approved.

The Public Works Department will serve as the general contractor for the project. Mr. Lopez is recommending and requesting the council to waive competitive bidding and enter into contracts with the listed contractors in the best interest of the city.
