MINUTES

CITY OF HIALEAH GARDENS TUESDAY, August 16, 2011 CITY COUNCIL CHAMBERS 10001 NW 87 AVENUE

- **1. Call to Order:** Chairman Garcia called the meeting to order at 7:35 p.m.
- **2. Roll Call:** Present were Chairman Luciano Garcia, Councilman Jorge A. Merida, Councilman, Jorge Gutierrez and Councilman Elmo L. Urra. Also present were Mr. J. Frost Walker, III serving as counsel. Councilman Piña, Mayor Yioset De La Cruz and City Attorney Charles Citrin were absent.
- **3. Invocation:** Chairman Garcia gave the invocation.
- **4. Pledge of Allegiance:** Councilman Gutierrez led the Pledge of Allegiance.
- **5. Deletions / Emergency Additions:** None were offered.
- **6. Review of Minutes:** August 2, 2011. Chairman Garcia made a motion to approve the minutes of August 2. 2011, seconded by Councilman Merida. The motion was unanimously approved.
- **7. Public Comments:** None were offered.

8. Presentation of Proclamation for Miami-Dade Alzheimer's City Challenge to Mr. Bill Sussman, Chairman of the Miami-Dade Walk: Mayor Yioset De La Cruz.

Chairman Garcia introduced Mr. Enrique Pineiro who came on behalf of Mr. Bill Sussman. Mr. Pineiro said a few words regarding the affliction of Alzheimer's disease and the efforts being made for treatment. Chairman Garcia then presented Mr. Pineiro with a proclamation from the city on behalf of the Mayor and Council

9. Proposed Resolutions:

A) RESOLUTION OF THE CITY COUNCIL OF THE CITY OF HIALEAH GARDENS, FLORIDA; AUTHORIZING CAPITAL PROJECT CONSISTING OF THE ACQUISITION AND CONSTRUCTION OF CERTAIN INFRASTRUCTURE IMPROVEMENTS IN THE NORTHWEST DISTRICT OF THE CITY; AUTHORIZING THE BORROWING BY THE CITY OF NOT TO EXCEED \$10,000,000 TO FINANCE A PART OF THE COSTS OF SAID CAPITAL PROJECT; ACCEPTING THE PROPOSAL OF REGIONS BANK ("LENDER") TO PROVIDE THE CITY WITH A LOAN NOT TO EXCEED \$10,000,000 TO FINANCE A PART OF THE COSTS OF SAID CAPITAL PROJECT; AUTHORIZING THE EXECUTION AND DELIVERY OF A LOAN AGREEMENT WITH SAID LENDER IN SUBSTANTIALLY THE SAME FORM AS ATTACHED HERETO AS EXHIBIT PURSUANT TO WHICH THE CITY WILL ISSUE A SPECIAL ASSESSMENT IMPROVEMENT BOND SECURE THE REPAYMENT OF SAID LOAN AND WILL PLEDGE TO THE PAYMENT OF SUCH BOND SPECIAL ASSESSMENTS LEVIED **AGAINST** BENEFITTED PROPERTY AND COLLECTED FROM THE OWNERS THEREOF AND OTHER MONEYS IN THE FUNDS AND ACCOUNTS HELD PURSUANT TO THE AGREEMENT: AUTHORIZING THE ISSUANCE OF SUCH BOND IN A PRINCIPAL AMOUNT OF NOT TO EXCEED \$10,000,000 PURSUANT TO THE LOAN AGREEMENT; DESIGNATING SUCH BOND FOR THE EXCEPTION TO THE PROVISIONS CONTAINED IN THE INTERNAL REVENUE CODE OF 1986 WHICH DENY FINANCIAL INSTITUTIONS ANY DEDUCTIONS FOR INTEREST EXPENSE ALLOCABLE TO TAX-EXEMPT OBLIGATIONS; AUTHORIZING THE EXECUTION AND DELIVERY OF OTHER DOCUMENTS IN CONNECTION WITH SAID LOAN; PROVIDING FOR CONFLICTS; PROVIDING FOR SEVERABILITY AND PROVIDING AN EFFECTIVE DATE.

Mr. Walker read the full title of the resolution into the record. Mr. Marcos Piloto, O.M.B. Director came forward and read his memo into the record recommending the financing proposal provided by Regions Bank for the Special Assessment Bank Loan RFP 2011-02 as advertised for the NW District improvements. Chairman Garcia confirmed with Mr. Piloto that the city had complied with all public notices and requirements as per Florida Statutes regarding the levying of the special assessment. Chairman Garcia then made a motion to approve, seconded by Councilman Merida. The motion was unanimously approved.

B) RESOLUTION OF THE CITY OF HIALEAH GARDENS. FLORIDA. AUTHORIZING THE ENTERING INTO AN **AGREEMENT** WITH **GOVERNMENT SERVICES** GROUP, INC.; WAIVING COMPETITIVE BIDDING; AUTHORIZING THE MAYOR TO EXECUTE AN AGREEMENT WITH GOVERNMENT SERVICES GROUP, INC.; PROVIDING **FOR** CONFLICTS: PROVIDING FOR SEVERABILITY: AND PROVIDING FOR AN EFFECTIVE DATE.

Mr. Walker read the full title of the resolution into the record. Mr. Marcos Piloto, O.M.B. Director came forward and read his memo into the record requesting the approval to enter into an agreement with Government Services Group, Inc. to assist in implementing the special assessment program. Chairman Garcia made a motion to approve, seconded by Councilman Merida. The motion was unanimously approved.

10. Second Reading / Public Hearing for consideration and final adoption of the following ordinance:

A) ORDINANCE OF THE CITY OF HIALEAH GARDENS, FLORIDA, AMENDING CHAPTER 40 "HIALEAH GARDENS POLICE PENSION TRUST FUND" OF THE CITY CODE BY AMENDING SECTION 40-214 "NORMAL RETIREMENT AGE" AND SECTION 40-281 "CALCULATION OF BENEFIT AMOUNT" TO IMPLEMENT THE PROVISIONS OF THE COLLECTIVE BARGAINING AGREEMENT BETWEEN THE CITY AND THE PBA; PROVIDING FOR CODIFICATION; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE.

Mr. Walker read the full title of the ordinance into the record. Chairman Garcia stated that the item had been discussed on first reading and proceeded to open the public hearing at 7:57 p.m. No one came forward at this time and he therefore closed the public hearing at 7:57 p.m. and made a motion to approve,

seconded by Councilman Merida. The motion was unanimously approved by individualized voice vote. **(4-0)**
