A) ORDINANCE OF THE CITY OF HIALEAH GARDENS, FLORIDA; REPEALING HIALEAH GARDENS CITY CODE CHAPTER 34 SECTION 2 (DISCHARGING FIREARMS IN PUBLIC); PROVIDING FOR CONFLICTS; PROVIDING FOR SEVERABILITY; AND PROVIDING FOR AN EFFECTIVE DATE.
