CITY OF HIALEAH GARDENS TUESDAY, December 20, 2011 CITY COUNCIL CHAMBERS 10001 NW 87 AVENUE

- **1. Call to Order:** Councilman Piña will be serving as Chairman for tonight's meeting in the absence of Councilman Luciano Garcia. The meeting was called to order at 7:30 p.m.
- **2. Roll Call:** Present were Chairman Rolando Piña, Councilman Jorge A. Merida, Councilman Elmo L. Urra and Councilman Jorge Gutierrez. Also present were Mr. Charles A. Citrin, City Attorney and Mayor Yioset De La Cruz.
- **3. Invocation:** Chairman Piña gave the invocation.
- 4. Pledge of Allegiance: Mayor De La Cruz led the Pledge of Allegiance.
- **5. Deletions / Emergency Additions:** None were offered.
- **6. Review of Minutes:** December 6, 2011. Chairman Piña made a motion to approve the minutes of December 6, 2011, seconded by Councilman Merida. The motion was unanimously approved.
- **7. Public Comments:** None were offered.

8. Requesting approval of vendors and expenditures for R.F.P. PW-11-100, North West District Infrastructure Improvements-Roadways: Mr. Joe Lopez, Public Works Director.

Mr. Joe Lopez, Public Works Director came forward and gave details of the cost estimate for the construction activities for the North West District Roadway Improvement Project (PW-11-100). All estimates are based on actual quotes provided by proposed vendors and include a 10 % contingency. Mr. Lopez requested that the City Council waive competitive bidding and enter into contract with listed vendors. Mr. Lopez answered Mr. Citrin's and Council members' questions regarding vendor pricing and informed that all the work would be done by the city's Public Works department. Based on staff's review and recommendation, Chairman Piña made a motion to approve, seconded by Councilman Merida. The motion was unanimously approved.
