

## **MINUTES**

1. **Call to Order:** Chairman Garcia called the meeting to order at 7:32 p.m.
2. **Roll Call:** Present were Chairman Luciano Garcia, Councilman Elmo L. Urrea, Councilman Jorge Gutierrez, Councilman Jorge A. Merida and Councilman Rolando Piña. Also present were Mayor Yioiset De La Cruz and City Attorney Charles A. Citrin.
3. **Invocation:** Chairman Garcia gave the invocation.
4. **Pledge of Allegiance:** Mayor De La Cruz led the Pledge of Allegiance.
5. **Deletions/Emergency Additions:** Item 9, Review of Waste Management Franchise Agreement was deleted from the Agenda.
6. **Review of Minutes:** September 16 2008. Chairman Garcia made a motion to approve the minutes of September 16, 2008, seconded by Councilman Merida. The motion was unanimously approved.
7. **Public Comments:** None were offered.
8. **Recommendation for Roadway expansion/drainage improvements of N.W. 122<sup>nd</sup> Street from N.W. 97<sup>th</sup> Avenue to Hialeah Gardens Boulevard (Bid No. PW 08-120):** Mr. Jose M. Lopez, Public Works Director.

Mr. Jose M. Lopez, Public Works Director came forward and read his memorandum into the record to award the contract to Acosta Tractors, Inc. which was the sole bidder and quoted within the budget for the project.

Mayor De La Cruz made comments regarding the time frame of this project and the notice to proceed will be issued within two weeks. Chairman Garcia made a motion to approve, seconded by Councilman Merida. The motion was unanimously approved. A resolution will be prepared to effect for the next council meeting.

- A) RESOLUTION OF THE CITY OF HIALEAH GARDENS, FLORIDA, AUTHORIZING ENTERING INTO A MUTUAL AID AGREEMENT WITH THE CITY OF MIAMI BEACH, FLORIDA REGARDING LAW ENFORCEMENT ISSUES AND NEEDS; AUTHORIZING THE EXECUTION OF SUCH AGREEMENT BY THE MAYOR; RATIFYING THE PROVISIONS OF SUCH AGREEMENT; PROVIDING FOR CONFLICTS; PROVIDING FOR SEVERABILITY; AND PROVIDING FOR AN EFFECTIVE DATE.
