## CITY COUNCIL CHAMBERS 10001 NW 87 AVENUE

- 1. **Call to Order:** Chairman Garcia called the meeting to order at 7:31 p.m.
- 2. **Roll Call:** Present were Chairman Luciano Garcia, Councilman Elmo L. Urra, Councilman Jorge Gutierrez, and Councilman Jorge A. Merida. Also present were Mayor Yioset De La Cruz and Assistant City Attorney. Councilman Rolando Piña was absent.
- 3. **Invocation:** Chairman Garcia gave the invocation.
- 4. **Pledge of Allegiance:** Mayor De La Cruz led the Pledge of Allegiance.
- 5. **Deletions/Emergency Additions:** None were offered.
- 6. **Review of Minutes:** December 2, 2008. Chairman Garcia made a motion to approve the minutes of December 2, 2008, seconded by Councilman. The motion was unanimously approved.
- 7. **Public Comments:** None were offered.
- 8. Request for transfer of ownership for 2COP alcohol beverage license for Gujor Inc. /dba/ El Rincon Criollo, 9605 N.W. 79 Avenue Bay No. 17 18, Hialeah Gardens, FL: Ms. Zenaida Castillo, Owner.

The following individuals came forward and gave testimony:

Mr. Robert Lorenzo, Chief of Business License Tax Department

Ms. Zenaida Castillo, the applicant was present. Mr. Robert Lorenzo Administrator of the Business License Tax Department came forward and read staff's recommendation for approval of the 2COP alcohol beverage license into the record. No one addressed the item. Chairman Garcia made a motion to approve, seconded by Councilman Merida. The motion was unanimously approved.

Mr. Marcos Piloto, Director of O.M.B came forward and opened the two sealed received:

Mr. Piloto came forward and gave a recommendation of awarding the bid to Jem Printing & Copy Service which was the lowest responsible bidder. Chairman Garcia made a motion to approve, seconded by Councilman Merida. The motion was unanimously approved. A resolution will be prepared to memorialize this action.

to approve, seconded by Councilman Merida. The motion was unanimously approved.

Mr. Citrin read the full title of the resolution into the record. Chief Toth came forward and gave details of the purchase of the vehicle to be used by the Police Department. The cost obtained was below the Florida Sheriff's Association, and was provided by Rivera Potamkin Dodge. Chairman Garcia made a motion to approve, seconded by Councilman Merida. The motion was unanimously approved.

Mr. Citrin read the full title of the resolution into the record. Mr. Marcos Piloto, Director of O.M.B. came forward and gave details of the purchase of the vehicle to be used by the Parks and Recreation Department. The cost obtained was below the Florida Sheriff's Association, and was provided by Gus Machado Ford. Chairman Garcia made a motion to approve, seconded by Councilman Merida. The motion was unanimously approved.

CONTRACT AS ALLOWED BY SECTION 46-119 OF THE HIALEAH GARDENS CODE OF ORDINANCES; AUTHORIZING THE APPROPRIATE CITY OFFICIALS TO EXECUTE AN AGREEMENT WITH GUS MACHADO FORD; PROVIDING FOR CONFLICTS; PROVIDING FOR SEVERABILITY; AND PROVIDING FOR AN EFFECTIVE DATE.

Mr. Citrin read the full title of the resolution into the record. Mr. Marcos Piloto, Director of O.M.B. came forward and gave details of the purchase of the vehicles to be used by the Maintenance Department piggybacking on a City of Miami's contract price. The contract price was below the Florida Sheriff's Association bid. Chairman Garcia made a motion to approve, seconded by Councilman Merida. The motion was unanimously approved.

E) RESOLUTION OF THE CITY OF HIALEAH GARDENS, FLORIDA, AUTHORIZING ENTERING INTO AGREEMENTS WITH SELECTED CONTRACTORS FOR THE REHABILITATION OF QUALIFIED OWNER-OCCUPIED CONDOMINIUM UNITS AT THE SAMARI LAKE EAST CONDOMINIUMS; PROVIDING FOR CONFLICTS; PROVIDING FOR SEVERABILITY; AND PROVIDING FOR AN EFFECTIVE DATE.

Mr. Citrin read the full title of the resolution into the record. Mr. Jerry Bell came forward and gave details of the entering into an agreement with pre-qualified contractors for the renovations to Samari Lake East Condominiums with funds appropriated by the Miami-Dade County OCED/Home funds. The contractors were present in the audience and were introduced. Based on approval the walk through will be scheduled with the unit owners and then the city can enter into an agreement with the contractors. Chairman Garcia made a motion to approve, seconded by Councilman Merida. The motion was unanimously approved.

F) RESOLUTION OF THE CITY OF HIALEAH GARDENS, FLORIDA, AMENDING THE GENERAL FUND FOR THE FISCAL YEAR BEGINNING OCTOBER 1, 2007 ENDING SEPTEMBER 30, 2008. RECOGNIZING A BUDGET INCREASE OF \$2,155.400.00 (TWO MILLION ONE HUNDRED FIFTY FIVE THOUSAND FOUR HUNDRED) AS A RESULT OF A REQUIRED DEVELOPER CONTRIBUTION: PROVIDING CONFLICTS; PROVIDING FOR SEVERABILITY; AND PROVIDING FOR AN EFFECTIVE DATE.

Mr. Citrin read the full title of the resolution into the record. Mr. Marcos Piloto, Director of O.M.B. came forward and gave and explanation for the need to amend the General Fund for FY 07/08 to provide for a required developer contribution received by the city. Chairman Garcia made a motion to approve, seconded by Councilman Merida. The motion was unanimously approved.

FOR THE PURCHASE OF BAHIA SOD TO BE USED THROUGHOUT THE BASEBALL FIELDS LOCATED AT WESTLAND **GARDENS** PARK; WAIVING **AUTHORIZING** COMPETITIVE BIDDING; APPROPRIATE CITY OFFICIALS TO EXECUTE AN AGREEMENT WITH GROUND KEEPERS; PROVIDING FOR CONFLICTS; PROVIDING FOR SEVERABILITY; AND PROVIDING FOR AN EFFECTIVE DATE.

Mr. Citrin read the full title of the resolution into the record. Mr. Marcos Piloto, Director of O.M.B. came forward and gave details of the need to purchase Bahia Sod to be used at the baseball fields at Westland Gardens Park. Quotes were received from local vendors. Ground Keepers provided a cost for sod without installation and the city will use the city's labor force to install the sod. The baseball program registration and games will begin at the park in January therefore; there is a time restraint to go forward with the purchase. Chairman Garcia made a motion to approve, seconded by Councilman Merida. The motion was approved with Councilman Urra off the dais.

H) RESOLUTION OF THE CITY OF HIALEAH GARDENS, FLORIDA, AUTHORIZING AND RATIFYING THE ENTERING INTO AN AGREEMENT WITH SOIL TECH DISTRIBUTORS, INC., FOR THE PURCHASE OF CLAY TO BE USED THROUGHOUT THE BASEEBALL FIELDS LOCATED AT WESTLAND GARDENS PARK; WAIVING COMPETITIVE BIDDING; UTILIZING AN EXISTING CITY OF FT. LAUDERDALE CONTRACT; RATIFYING THE DECISION TO ENTER INTO AN AGREEMENT WITH SOIL TECH DISTRIBUTIORS; PROVIDING FOR CONFLICTS; PROVIDING FOR SEVERABILITY; AND PROVIDING FOR AN EFFECTIVE DATE.

Mr. Citrin read the full title of the resolution into the record. Mr. Marcos Piloto, Director of O.M.B. came forward and gave details of the purchase of clay to be used at the baseball fields at Westland Gardens Park. Mr. Walter Dubon, Director of the Parks obtained quotes and Soil Tech came in a the lowest responsible vendor and it is recommended to go forward with the purchase from this vendor who has a municipal contract with the City of Fort Lauderdale on which the city will piggyback.

Chairman Garcia made a motion to approve, seconded by Councilman Merida. The motion was unanimously approved.

Chairman Garcia opened the public hearing at 8:01 p.m. No one came forward; Chairman Garcia closed the public hearing at 8:01 p.m. Chairman Garcia made a motion to approve, seconded by Councilman Merida. The motion was approved by individualized voice vote (**4-0**).
