MINUTES

CITY OF HIALEAH GARDENS TUESDAY, AUGUST 7, 2007

- 1. **Call to Order:** Chairman Garcia called the meeting to order at 7:30 p.m.
- 2. **Roll Call:** Present were Chairman Luciano Garcia, Councilman Jorge Gutierrez, Councilman Jorge A. Merida, Councilman Rolando Piña and City Attorney Charles A. Citrin. Mayor Yioset De La Cruz and Councilman Elmo L. Urra were absent.
- 3. **Invocation:** Chairman Garcia led the invocation.
- 4. **Pledge of Allegiance:** Councilman Piña led the Pledge of Allegiance.
- 5. **Deletions/Emergency Additions:** Chairman Garcia made a motion to delete item 9 from the agenda, there were no objections therefore the motion was approved.
- 6. **Review of Minutes:** June 19, 2007. Chairman Garcia made a motion to approve the minutes of June 19, 2007, seconded by Councilman Merida. The motion was unanimously approved.
- 7. **Public Comments:** None were offered.
- 8. Request for approval of 2COP alcohol beverage license transfer of ownership for La Cocina Latina, 10550 N.W. 77 Court Bay #101-104, Hialeah Gardens, Florida: Mr. Jose Miguel Gomez-Santana, Owner.

The following individuals came forward and gave testimony:

Mrs. Aida Martinez Ruiz, Assistant City Attorney came forward and read staff's recommendation for approval of the 2COP alcohol beverage license into the record. No one addressed the item. Chairman Garcia made a motion to approve, seconded by Councilman Merida and the motion was unanimously approved.

10. Proposed Resolution:

A) RESOLUTION OF THE CITY OF HIALEAH GARDENS, FLORIDA APPROVING THE RENEWAL OF THE AGREEMENT BETWEEN THE DEPARTMENT OF TRANSPORTATION, STATE OF FLORIDA, AND THE CITY OF HIALEAH GARDENS CONCERNING TURF AND LANDSCAPE MAINTENANCE; PROVIDING FOR SEVERABILITY; AND PROVIDING FOR AN EFFECTIVE DATE.

Mr. Citrin read the full resolution into the record. Mrs. Aida Martinez Ruiz stated that this was a renewal of the agreement between the State of Florida Department of Transportation and the city. Chairman Garcia made a motion to approve, seconded by Councilman Merida. The motion was unanimously approved.

11. Second Reading / Public Hearing for consideration and final adoption of the following ordinances:

A) ORDINANCE OF THE CITY OF HIALEAH GARDENS, FLORIDA, APPROVING A WAIVER OF PLAT FOR FELIX ACOSTA. LEGAL DESCRIPTION: PARENT TRACT: ALL OF TRACT 3, LESS THE WEST 330 FEET THEREOF, OF "FLORIDA FRUIT LANDS COMPANY'S SUBDIVISION NO. 1", OF SECTION 29, TOWNSHIP 52 SOUTH, RANGE 40 EAST, ACCORDING TO THE PLAT THEREOF, RECORDED IN PLAT BOOK 2, AT PAGE 17 OF THE PUBLIC COUNTY, FLORIDA. RECORDS OF MIAMI-DADE APPROXIMATE LOCATION: N.W. 97 AVENUE AND 135 STREET, HIALEAH GARDENS, FLORIDA, FOLIO #: 27-2029-001-0030; PROVIDING FOR CONDITIONS; PROVIDING FOR EFFECTIVE DATE. B) ORDINANCE OF THE CITY OF HIALEAH GARDENS, FLORIDA, AMENDING CHAPTER 46 OF THE CODE OF ORDINANCES FOR THE PURPOSE OF ADOPTING THE STANDARD INDUSTRIAL CLASSIFICATION MANUAL NORTH AMERICAN INDUSTRY CLASSIFICATION SYSTEM (NAICS) TO CLASSIFY ALL OCCUPATION AND ECONOMIC ACTIVITIES IN THE ENTIRE CITY; TO ADOPT A NEW OCCUPATIONAL LICENSE SCHEDULE FOR THE ENTIRE CITY; PROVIDING FOR INCLUSION ΙN THE CODE; PROVIDING SEVERABILITY; PROVIDING FOR AN EFFECTIVE DATE.

Mr. Citrin read the full title of the ordinance into the record. Mrs. Mirtha S. Gonzalez, Chief Zoning Official came forward and gave details on the creation of a new schedule of license fees for the entire city including the annexed area. Chairman Garcia opened the public hearing at 7:37 p.m. No one came forward; Chairman Garcia closed the public hearing at 7:37 p.m. A motion to approve was made by Chairman Garcia, seconded by Councilman Merida. The motion was unanimously approved by individualized voice vote (**Vote 4-0**).
