MINUTES

CITY OF HIALEAH GARDENS TUESDAY, JANUARY 17, 2006

CITY COUNCIL CHAMBERS 10001 NW 87 AVENUE

- 1. Call to Order: Chairman Luciano Garcia called the meeting to order at 7:30 p.m.
- 2. **Roll Call:** Present were Chairman Luciano Garcia, Councilman Elmo L. Urra, Councilman Jorge Gutierrez and Councilman Jorge A. Merida. Also present were Mayor Yioset De La Cruz and City Attorney Charles A. Citrin. Councilman Rolando Piña was absent.
- 3. **Invocation:** Chairman Garcia led the invocation.
- 4. **Pledge of Allegiance:** Mayor De La Cruz led the Pledge of Allegiance.
- 5. **Deletions/Emergency Additions:** Opening of sealed bids for PW-05-B100 and PW-05-B110 will be added to the Agenda as Item 8A.
- 6. **Review of Minutes:** January 3, 2006. Chairman Garcia made a motion to approve the minutes of January 3, 2006, seconded by Councilman Merida. The motion was unanimously approved.
- 7. Public **Comments:** None were offered.
- 8. Request for approval for utilization of Police Department Forfeiture Fund Chief Van Toth.

Chief Van Toth came forward and gave details of the use of the forfeiture funds to link the police main station records with the police substation. Chairman Garcia made a motion to approve, seconded by Councilman Merida. The motion was unanimously approved.

8A. Opening of sealed bids for PW-05-B100 and PW-05-B110.

Mr. Jose M. Lopez, Public Works Director came forward and opened the following bids:

Chairman Garcia made a motion to approve the lowest bidder and instructed staff to review the bid and return with a recommendation for final approval at the next council meeting, seconded by Councilman Merida. The motion was unanimously approved.

Chairman Garcia made a motion to approve, seconded by Councilman Merida. The motion was unanimously approved by individualized voice vote (**Vote 4-0**).

Mr. Citrin read the full title of the ordinance into the record. This is a City initiated request. Chairman Garcia stated that this was a first reading and as such, an opportunity for public input would be provided upon second reading. Chairman Garcia made a motion to approve, seconded by Councilman Merida. The motion was unanimously approved by individualized voice vote (Vote 4-0).

Mr. Citrin sworn in those who would be testifying on the item for second reading. Mr. Citrin read the full title of the ordinance into the record. Mr. Juan Carlos Hernandez was present for the applicant. Mrs. Mirtha S. Gonzalez, Chief Zoning Official came forward and gave staff recommendations. Chairman Garcia opened the public hearing at 7:46 p.m. No one came forward; Chairman Garcia closed the public hearing at 7:46 p.m.

Chairman Garcia made a motion to approve, seconded by Councilman Merida. The motion was unanimously approved by individualized voice vote (Vote 4-0).

- 11. City Attorney's Report: Mr. Citrin had no comments.
- 12. **Mayor's Report Miscellaneous:** The Mayor reported that construction of the new police department would begin January 21, 2006. Construction of NW 122 Street, Phase I, from Frontage Road to NW 97 Avenue will begin in March and it will last until the end of the month. Phase II, from NW 97 Avenue to NW 92 Avenue and Phase III from NW 92 Avenue to NW 89 Avenue will follow. We will have the interlocal agreement from the county by the middle of this month for the construction of the public library, which will approximately begin in July of this year. Renovations for City Hall will begin next year.
- 13. **Council Members Concerns/Reports:** Chairman Garcia commended Mrs. Mirtha S. Gonzalez, Mr. J. Frost Walker, and staff for working on the zoning revisions.
- 14. Adjournment: The meeting was adjourned at 7:50 p.m.
