#### **MINUTES**

- 1. Call to Order: Chairman Luciano Garcia called the meeting to order at 7:39 p.m.
- 2. **Roll Call:** Present were Chairman Luciano Garcia, Councilman Elmo L. Urra, Councilman Jorge A. Merida, Councilman Jorge Gutierrez and Councilman Rolando Piña. Also present were Mayor Yioset De La Cruz and serving as City Attorney Aida Martinez Ruiz.
- 3. **Invocation:** Chairman Garcia led the invocation.
- 4. **Pledge of Allegiance:** Mayor De La Cruz led the Pledge of Allegiance.
- 5. **Deletions/Emergency Additions:** Request for approval to purchase emergency replacement sewage pumps was added as Item 10A.
- 6. **Review of Minutes:** August 15, 2006. Chairman Garcia made a motion to approve the minutes of August 15, 2006, seconded by Councilman Merida. The motion was unanimously approved.

Mr. Arturo L. Ruiz came forward and gave staff's recommendation to approve the 2COP license. Chairman Garcia made a motion to approve, seconded by Councilman Merida. The motion was unanimously approved.

10A. Request for approval to purchase Emergency Replacement Pumps for Sanitary Sewage Pump Station No. 4: Mr. Albert Nielson, Director of Water and Sewer Department.

Mr. Albert Nielson, Director of the Water and Sewer Department came forward and gave details for the need to purchase emergency replacement pumps for the sanitary sewage pump station due to age and a power overload created by a high intense electrical storm. The cost will be of \$13,000 each for two temporary smaller pumps, which TAW Service Center has in stock and can deliver in ten days. The larger pumps will go through the request for proposals process or Mr. Nielson will provide cost estimates from qualified vendors. Chairman Garcia made a motion to approve, seconded by Councilman Merida. The motion was unanimously approved. Staff was instructed to memorialize this action at the next council meeting.

Mrs. Martinez-Ruiz read the full title of the resolution into the record. Mrs. Martinez-Ruiz elaborated on the particulars of the agreement, which included an explanation of the grant monies received by the City to repair erosion damage to the lake bank behind Misty Point Villas caused by Hurricane Wilma. Mayor De La Cruz elaborated further that because the property is privately owned it was necessary for the owners to contribute 17.5 percent of the project's cost. Chairman Garcia made a motion to approve, seconded by Councilman Merida. The motion was unanimously approved.

Mrs. Martinez-Ruiz swore in all those who would be testifying on any of the items regarding the adoption of the City's budget as the first reading is also treated as a public hearing. Mrs. Martinez-Ruiz read the full title of the ordinance into the record. Mayor De La Cruz commented that the City has not raised taxes for the past four years and has a millage rate as low as it was in 1984. He also commented that the reflected increase in taxes is due to an increase in the county assessment of property values. Chairman Garcia pointed out the successes of the hard work of Mayor De La Cruz and his administration to provide more services without raising taxes. Mr. August Torres accountant for the City came forward and rated the City a ten on a scale of one to ten. He also gave the City an A+ rating and stated that the City was in an excellent fiscal condition. Chairman Garcia opened the public hearing at 8:15 pm. Mr. Julio Lopez, President of the Misty Point Villas Condominium Association came forward and thanked Mayor De La Cruz for his efforts to secure the funding for the lake erosion repair work. Chairman Garcia closed the public hearing at 8:17 p.m. Councilman Gutierrez added positive comments on the budget. Chairman Garcia made a motion to approve, seconded by Councilman Merida.
