CITY COUNCIL MEETING TUESDAY, APRIL 5, 2005

CITY COUNCIL CHAMBERS 10001 NW 87 AVENUE

- 1. Call to Order: Chairman Garcia called the meeting to order at 7:37 p.m.
- 2. **Roll Call:** Present were Chairman Luciano Garcia, Councilman Jorge Gutierrez, Councilman Jorge A. Merida, Councilman Manuel Zardon and Councilman Rolando Piña. Also present was City Attorney, Charles A. Citrin. Mayor Yioset De La Cruz was absent.
- 3. **Invocation:** Chairman Luciano Garcia led the invocation.
- 4. **Pledge of Allegiance.** Councilman Rolando Piña led the Pledge of Allegiance.
- 5. **Deletions/Emergency Additions:** Item 8A was deleted from the Agenda. A resolution authorizing the contracting of MCO Environmental Inc. was added to the Agenda as Item 8I.
- 6. **Review of Minutes:** March 15, 2005. Chairman Garcia made a motion to approve the minutes of March 15, 2005, seconded by Councilman Merida. The motion was unanimously approved.
- 7. **Public Comments:** None were offered.
