MINUTES

CITY COUNCIL MEETING TUESDAY, JUNE 7, 2005

CITY COUNCIL CHAMBERS 10001 NW 87 AVENUE

- 1. Call to Order: Chairman Garcia called the meeting to order at 7:42 p.m.
- 2. **Roll Call:** Present were Chairman Luciano Garcia, Councilman Jorge Gutierrez, Councilman Manuel Zardon and Councilman Rolando Piña. Also present were Mayor Yioset De La Cruz and City Attorney Charles A. Citrin. Councilman Jorge Merida joined the meeting at 7:45 p.m.
- 3. **Invocation:** Chairman Luciano Garcia led the invocation.
- 4. **Pledge of Allegiance:** Mayor Yioset De La Cruz led the Pledge of Allegiance.
- 5. **Deletions/Emergency Additions:** None were offered.
- 6. **Review of Minutes:** May 17, 2005. Chairman Garcia made a motion to approve the minutes of May 17, 2005, seconded by Councilman Gutierrez. The motion was unanimously approved.
- 7. **Public Comments:** No one came forward.
- 8. **Discussion of schedule for summer recess:** Chairman Garcia stated that the City Council would be taking a recess in the month of July.
- 9. **Discussion regarding Bus Bench Advertising:** Mr. Marcos Piloto, O.M.B. Director.

Mr. Marcos Piloto came forward and explained that a sealed bid was received for bus bench advertisement from Culver Amherst at the last council meeting. The minimum license fee was not met, therefore the bid is deemed non responsive and was rejected. At this time, Mayor De La Cruz recommended to table the item. Chairman Garcia made a motion to table the item seconded by Councilman Gutierrez. The motion was unanimously approved. (**Tabled**)

10. **Proposed Resolutions:**

Mr. Citrin read the full resolution into the record. Mr. Marcos Piloto, O.M.B. Director came forward and explained the details of the renewal contract with the Florida Department of Transportation regarding the turf and landscape maintenance agreement. Chairman Garcia made a motion to approve, seconded by Councilman Merida. The motion was unanimously approved.

B) RESOLUTION OF THE CITY OF HIALEAH GARDENS,
FLORIDA, AUTHORIZING THE AWARD OF A CONTRACT
FOR ROADWAY IMPROVEMENTS TO NW 107TH AVENUE;
WAIVING COMPETITIVE BIDDING; AUTHORIZING THE

Mr. Citrin read the full title of the resolution into the record. Mr. Jose M. Lopez, Public Works Director gave details to extend the agreement with Southeastern Engineering for roadway improvements to NW 107 Avenue. Chairman Garcia made a motion to approve, seconded by Councilman Merida. The motion was unanimously approved.

C) RESOLUTION OF THE CITY OF HIALEAH GARDENS, FLORIDA, APPROVING AND RATIFYING THE AGREEMENT FOR DENTAL INSURANCE BETWEEN FORTIS AND THE CITY OF HIALEAH GARDENS; PROVIDING FOR SEVERABILITY; PROVIDING FOR EFFECTIVE DATE.

Mr. Citrin read the full resolution into the record in the absence of Aida Martinez-Ruiz. Mr. Marcos Piloto, O.M.B. Director came forward and gave details of the proposals received from Cigna and Fortis, the City's current carrier for the employees' dental insurance plan. Staff recommendations are to continue to utilize the current plan with Fortis. This plan has no increase in premiums for HMO participants and the rate increase for PPO members is minimal. Ms. Samantha Alvarez representing Brown & Brown our agent was present. Chairman Garcia made a motion to approve, seconded by Councilman Merida. The motion was unanimously approved.

Mr. Citrin complimented Mrs. Aida Martinez Ruiz on her efforts and the fine job done.

Mr. Citrin asked the Council to add to the Agenda a discussion on the approval of the Sanitary Sewer Evaluation study at the end of the meeting prior to the City Attorney's Report.

Mr. Citrin read the full resolution into the record in the absence of Aida Martinez-Ruiz. This resolution will serve to ratify the action taken at the last meeting to enter into a contract with AIG/Valic as the City's third party administrator for the employee pension plan. Chairman Garcia made a motion to approve, seconded by Councilman Merida. The motion was unanimously approved.

Gonzalez, Chief Zoning Official came forward and gave staff recommendations. Mr. Osman came forward and gave a detailed explanation of the variances and site plan. Chairman Garcia opened the public hearing for a side setback variance at 8:05 p.m. No one came forward; Chairman Garcia closed the public hearing at 8:05 p.m. A motion to approve a variance of a five feet side setback was made by Chairman Garcia, seconded by Councilman Merida. The motion was approved by individualized voice vote. (5-0) Chairman Garcia opened the public hearing for a variance to allow a trash enclosure in the greenbelt area at 8:07 p.m. No one came forward; Chairman Garcia closed the public hearing at 8:07 p.m. A motion to approve a variance to allow a trash enclosure in the greenbelt area was made by Chairman Garcia, seconded by Councilman Merida. The motion was approved by

individualized voice vote. **(5-0)** Chairman Garcia opened the public hearing for a one-foot variance at 8:15 p.m. No one came forward; Chairman Garcia closed the public hearing at 8:15 p.m. A motion to approve a variance of one-foot from the property line to the parking area was made by Chairman Garcia, seconded by Councilman Merida. The motion was approved by individualized voice vote. **(5-0)** A motion to approve the site plan was made by Chairman Garcia, seconded by Councilman Merida. The motion was unanimously approved by individualized voice vote. **(5-0)**

The motion was approved by individualized voice vote. (3-2) with Chairman Garcia and Councilman Peña voting against.

Discussion of Sanitary Sewer Evaluation Study: Charles A. Citrin

Mr. Citrin gave a report on the county mandated inflow/infiltration study of the City's sanitary sewer system. U.R.S. Corporation, the company approved by the City is ready to

begin the actual work that requires thirty (30) flow meters. The county through Mr. Albert Neilson's efforts has agreed to allow the City these flow meters at no cost, which would have cost the City \$4,000 each. However, these flow meters have to be calibrated at a cost of \$875 each. In addition, there is an extra \$600-\$700 in expenses. Chairman Garcia made a motion to approve the continuation of this study, seconded by Councilman Merida. The motion was unanimously approved.
