CITY COUNCIL MEETING TUESDAY, AUGUST 2, 2005

CITY COUNCIL CHAMBERS 10001 NW 87 AVENUE

- 1. Call to Order: Chairman Garcia called the meeting to order at 7:33 p.m.
- 2. **Roll Call:** Present were Chairman Luciano Garcia, Councilman Manuel Zardon, Councilman Jorge A. Merida, Councilman Jorge Gutierrez and Councilman Rolando Piña. Also present were Mayor Yioset De La Cruz, Assistant City Attorney Aida Martinez-Ruiz and Attorney J. Frost Walker III.
- 3. **Invocation:** Chairman Luciano Garcia led the invocation and introduced his son Austin Garcia and Brian Arnad who were in attendance.
- 4. **Pledge of Allegiance:** Mr. Austin Garcia and Mr. Brian Arnad of Troop 303 led the Pledge of Allegiance.
- 5. **Deletions/Emergency Additions:** Discussion of donations for local public schools was added to the Agenda as Item 10F.
- 6. **Review of Minutes:** June 21, 2005. Chairman Garcia made a motion to approve the minutes of June 21, 2005, seconded by Councilman Merida. The motion was unanimously approved.
- 7. **Public Comments:** None were offered.
- 8. Request for extension of deadline for the following bids: Mr. Marcos Piloto, O.M.B. PW-05-100 Government Complex Warehouse Building PW-05-110 Government Water and Sewer Offices PW-05-120 Hialeah Gardens Police Station

Mr. Marcos Piloto, Director of O.M.B. came forward and explained the need to extend the deadline to accept bids until September 8, 2005, as no bids had been received to date. Chairman Garcia made a motion to approve, seconded by Councilman Merida. The motion was unanimously approved.

Chairman Garcia made a motion to approve, seconded by Councilman Merida. The motion was unanimously approved.

Mrs. Martinez-Ruiz read the full title of the resolution into the record. Mrs. Martinez-Ruiz explained the award of a contract for the water and sewer extension for the Hialeah Gardens Government Complex to Acosta Tractors, Inc. Chairman Garcia made a motion to approve, seconded by Councilman Merida. The motion was unanimously approved.

Mrs. Martinez-Ruiz read the full title of the resolution into the record. Mayor De La Cruz explained the need for an extension of the recycling program. Chairman Garcia made a motion to approve, seconded by Councilman Merida. The motion was unanimously approved.

Chairman Garcia made a motion to approve, seconded by Councilman Gutierrez. The motion was unanimously approved.

Mr. Piloto reported on the quotes received from different vendors. Chairman Garcia made a motion to approve, seconded by Councilman Merida. The motion was unanimously approved.

Mayor De La Cruz requested that the \$200,000 donation to the City be distributed as follows: \$100,000 to Hialeah Gardens Elementary, \$30,000 to Mater Academy, \$30,000 to Youth Co-Op and the remaining \$40,000 for uniforms. Chairman Garcia made a recommendation for the \$100,000 donation to Hialeah Gardens Elementary, seconded by Councilman Merida. The motion was unanimously approved.

11. City Attorney's Report: Mrs. Martinez-Ruiz had no comments.

12. **Mayor's Report – Miscellaneous:** Mayor De La Cruz ceded his time to resident Cristina Blake Cabrera who had concerns over pot holes on the swale in front of her property. Mayor De La Cruz will have the Public Works Department look into the situation and address the issue.

13. Council Members Concerns/Reports – Board Appointments

Councilman Gutierrez thanked Mayor De La Cruz for the school donations and the additional funding for the Samari Lake home rehabilitation program.

14. **Adjournment:** The meeting was adjourned at 8:08 p.m.
