CITY COUNCIL MEETING TUESDAY, JANUARY 6, 2004

CITY COUNCIL CHAMBERS 10001 NW 87 AVENUE

- 1. Call to Order: Chairman Garcia called the meeting to order at 7:30 p.m.
- 2. **Roll Call:** Present were Chairman Luciano Garcia, Councilman Jorge Gutierrez, and Councilman Rolando Piña. Also present was City Attorney Charles A. Citrin. Councilman Jorge Merida and Councilman Manuel Zardon were absent.
- 3. **Invocation:** Chairman Luciano Garcia gave the invocation.
- 4. **Pledge of Allegiance:** Councilman Rolando Piña led the Pledge of Allegiance.
- 5. **Deletions/Emergency Additions:** None were offered.
- 6. **Review of Minutes:** December 16, 2003. Chairman Garcia made a motion to approve the minutes of December 16, 2003, seconded by Councilman Gutierrez. The motion was approved by unanimous consent.
- 7. **Public Comments:** The following individual came forward to address the Council:

8. Request for approval of 2COP alcohol beverage license transfer of ownership: Xtreme Car Care Group, Corp., 11601 W. Okeechobee Road, Hialeah Gardens: Mr. Zamir E. Gloria, Owner.

Mr. Zamir E. Gloria, the applicant came forward and gave details of the license application. Manace Rodriguez, Occupational License Director came forward and gave staff recommendations. Chairman Garcia made a motion to approve, seconded by Councilman Gutierrez. The motion was unanimously approved.

8. Request for approval of Water and Sewer Extension Agreements between J.J. Investments International, Inc., and the City of Hialeah Gardens for Subdivision known as Villas De Valencia located at N.W. 82nd Avenue and 99 Lane: Mr. Albert Nielson, Director of Water and Sewer Department came forward and gave a presentation on

the extension agreement; the Water Board has approved this agreement. Chairman Garcia made a motion to approve, seconded by Councilman Gutierrez. The motion was approved unanimously.

Mr. Citrin read the full title of the resolution into the record and gave a brief summary of issues addressed in the resolution, which was supported by the Leagues of Cities. Chairman Garcia made a motion to approve, seconded by Councilman Gutierrez and unanimously approved.

- 11. Second Reading/Public Hearing for consideration and final adoption of the following ordinances: At this time City Attorney, Charles A. Citrin swore in those individuals who would be offering testimony on the items for the public hearing.

Gonzalez, Chief Zoning Official came forward and gave department recommendations. Mr. Haim Wiener, the applicant, and project architect, Mr. Orlando Alonso were also present. Mr. Price proceeded to give details of the project, as did Mr. Alonso. Chairman Garcia opened the public hearing at 7:46 p.m. for discussion on the item. No testimony was offered; therefore, Chairman Garcia closed the public hearing at 7:46 p.m. Councilman Piña had questions for Chief H. Keith Joy regarding his negative vote on this project at the T.R.C. meeting. The Chief's concern was stacking during traffic hours. Chairman Garcia made a motion to approve, seconded by Councilman Gutierrez and unanimously approved by individualized voice vote (Vote 3-0).

Gonzalez, Chief Zoning Official came forward and gave department recommendations. Chairman Garcia opened the public hearing at 7:59 p.m. No one came forward; Chairman Garcia closed the public hearing at 7:50 p.m. Chairman Garcia made a motion to approve, seconded by Councilman Gutierrez and unanimously approved by individualized voice vote (Vote 3-0).

- 12. **City Attorney's Report:** Reported on the appeal to the City's Land Use Amendment Application regarding 84 Holdings, LLC., and commended Mr. J. Frost Walker III for this work on the issue.
- 13. **Mayor's Report Miscellaneous:** The Mayor was not present.
- 14. **Council Members Concerns/Reports Miscellaneous:** Councilman Piña informed the Council that he would not be present for the next meeting.
- 15. **Adjournment:** The meeting was adjourned at 8:08 p.m.
