CITY COUNCIL MEETING TUESDAY, JANUARY 20, 2004

CITY COUNCIL CHAMBERS 10001 NW 87 AVENUE

- 1. **Call to Order:** Chairman Garcia called the meeting to order at 7:30 p.m.
- 2. **Roll Call:** Present were Chairman Luciano Garcia, Councilman Jorge Gutierrez, Councilman Jorge Merida and Councilman Manuel Zardon. Also present was City Attorney Charles A. Citrin. Councilman Rolando Piña was absent.
- 3. **Invocation:** Chairman Garcia gave the invocation.
- 4. **Pledge of Allegiance:** City Attorney Charles A. Citrin led the Pledge of Allegiance.
- 5. **Deletions/Emergency Additions:** None were offered.
- 6. **Review of Minutes:** January 6, 2003: Chairman Garcia made a motion to approve the minutes of January 6, 2004, seconded by Councilman Merida. The motion was approved by unanimous consent.
