CITY COUNCIL MEETING TUESDAY, FEBRUARY 3, 2004

CITY COUNCIL CHAMBERS 10001 NW 87 AVENUE

- 1. Call to Order: Chairman Garcia called the meeting to order at 7:41 p.m.
- 2. **Roll Call:** Present were Chairman Luciano Garcia, Councilman Jorge Merida, Councilman Jorge Gutierrez, and Councilman Rolando Piña. Also present was City Attorney Charles A. Citrin. Councilman Manuel Zardon was absent.
- 3. **Invocation:** Chairman Garcia gave the invocation.
- 4. Pledge of Allegiance: Councilman Rolando Piña led the Pledge of Allegiance.
- 5. **Deletions/Emergency Additions:** None were offered.
- 6. **Review of Minutes:** January 20, 2004: Chairman Garcia made a motion to approve the minutes of January 20, 2004, seconded by Councilman Merida. The motion was approved by unanimous consent.
- 7. **Public Comments:** None were offered.
- 8. Request for approval of 2COP alcohol beverage license: Rexra Investment, Inc. O.K. Cafeteria, 8050 N.W. 103 Street #104, Hialeah Gardens: Owner Rebeca Linares.

Ms. Rebeca Linares, the applicant was present. Mr. Arturo L. Ruiz, for the Occupational License Department came forward and deferred to Police Chief H. Keith Joy who offered testimony against the issuance of the license. Chairman Garcia made a motion to table the item at this time in order to allow the applicant to meet with staff, the motion was seconded by Councilman Merida, and unanimously approved.

9. Discussion of anticipated expenses for development of 10.5 acres adjacent to Westland Gardens Park: Mr. Marcos Piloto, O.M.B Director.

Mr. Marcos Piloto came forward, gave a report on the issue, and explained the anticipated expenses for the development project of the 10.5 acres acquired by the City that are adjacent to Westland Gardens Park. Mr. Jose M. Lopez, Public Works Director came forward and offered further details regarding the work particulars and the foreseen expenses.

10. **Discussion of change orders for Hydra-Samari Emergency Access Road Project:** Mr. Jose M. Lopez, Public Works Director.

Mr. Jose M. Lopez, Public Works Director came forward and gave a summary of the need for change orders on the Hydra-Samari Emergency Access Road. The change order includes items shown on the plans, but not listed in the itemization table in the bid package, and unforeseeable site conditions that needed to be addressed in order to complete the project. He added that the total amount of the project is still less than the second bid received. The City had been awarded a Community Development Block Grant, the County has approved a portion of the change order and a balance of the CDBG funds are still available, but there are no guarantees that the County will reimburse the City for these additional expenses. Mr. Lopez is requesting payment to be made to the contractor for the work completed. Chairman Garcia made a motion to approve the change orders and to instruct staff to prepare a resolution to this effect, seconded by Councilman Merida and unanimously approved.
