CITY COUNCIL MEETING TUESDAY, APRIL 6, 2004

CITY COUNCIL CHAMBERS 10001 NW 87 AVENUE

- 1. Call to Order: Chairman Garcia called the meeting to order at 7:32 p.m.
- 2. **Roll Call:** Present were Chairman Luciano Garcia, Councilman Manuel Zardon, Councilman Jorge Merida, and Councilman Jorge Gutierrez. Also present were Assistant City Attorney Aida C. Martinez Ruiz and Mayor Yioset De La Cruz. Councilman Rolando Piña joined the meeting at 7:34 p.m.
- 3. **Invocation:** Chairman Garcia gave the invocation.
- 4. **Pledge of Allegiance:** Mayor De La Cruz led the Pledge of Allegiance.
- 5. **Deletions/Emergency Additions:** None were offered.
- 6. **Review of Minutes:** March 16, 2004: Chairman Garcia made a motion to approve the minutes of March 16, 2004, seconded by Councilman Merida. The motion was approved by unanimous consent.
- 7. **Public Comments:** None were offered.
- 8. Request for approval of 2COP alcohol beverage license transfer of ownership for Latin America Tropical Restaurant, 8108 N.W. 103 Street, Hialeah Gardens, FL: Mr. Elvis Rafael Perez

Mr. Elvis Rafael Perez, the applicant was present. At this time, Mayor De La Cruz addressed the council and asked that this item be tabled to allow time for Arturo L. Ruiz, Director of Administration to arrive and address the issue. Chairman Garcia offered a motion to table the item seconded by Councilman Merida. The motion was unanimously approved (Tabled)

9. Recognition of "Officer of the Year", Officer Vicente Amor, and "Officers of the Month" for December 2003, Carlos Zerbinati, Manuel Valdes, and Vicente Amor: H. Keith Joy, Chief of Police.

Chief H. Keith Joy, Lieutenant Van Toth, and Mayor Yioset De La Cruz presented plaques to Carlos Zerbinati, Manuel Valdes and Vicente Amor for "Officers of the Month" for the month of December 2003, and to Vicente Amor for "Officer of the Year", and offered their congratulations for the officers' outstanding service.

At this time, Chairman Garcia made a motion to remove Item 8 from the table, seconded by Councilman Merida. Mr. Arturo L. Ruiz, Director of Administration came forward and gave favorable staff recommendations. Chairman Garcia made a motion to approve seconded by Councilman Merida and the item was approved unanimously.

Mrs. Aida Martinez Ruiz read the full ordinance into the record. Ms. Amy Khamissian was present. Chairman Garcia stated that this was a first reading and as such, an opportunity for public input will be provided upon second reading. He then made a

motion to approve, seconded by Councilman Merida. The motion was approved by individualized voice vote (5-0).

Mrs. Aida Martinez Ruiz read the full resolution into the record. Mrs. Martinez Ruiz explained that these resolutions were renewal contracts for the City's inspectors. The duration of the contracts will be for one year and will renew every year unless either party wishes to terminate the contract with thirty days notice. Chairman Garcia made a motion to approve seconded by Councilman Merida and motion was unanimously approved.
