MINUTES

CITY COUNCIL MEETING TUESDAY, MAY 4, 2004

CITY COUNCIL CHAMBERS 10001 NW 87 AVENUE

- 1. **Call to Order:** Chairman Garcia called the meeting to order at 7:33 p.m.
- 2. **Roll Call:** Present were Chairman Luciano Garcia, Councilman Manuel Zardon, Councilman Jorge A. Merida, Councilman Jorge Gutierrez, and Councilman Rolando Piña. Also present were Mayor Yioset De La Cruz and City Attorney Charles A. Citrin.
- 3. **Invocation:** Chairman Garcia gave the invocation.
- 4. **Pledge of Allegiance:** Mayor De La Cruz led the Pledge of Allegiance.
- 5. **Deletions/Emergency Additions:** None were offered.
- 6. **Review of Minutes: April 20, 2004:** Chairman Garcia made a motion to approve the minutes of April 20, 2004, seconded by Councilman Merida. The motion was approved unanimously.
- 7. **Public Comments:** None were offered.
- 8. **Request for reinstatement of alcohol beverage license for:** Artistas Restaurant, 9550 N.W. 79 Avenue #3, Hialeah Gardens: Owners Milagros Rodriguez and Julio E. Valdes
 - Mr. Julio E. Valdes was present. Mr. Arturo L. Ruiz, Director of Administration came forward and gave staff recommendations to reinstate the alcohol beverage license being that there were no violations during the probation period. Chairman Garcia made a motion for reinstatement, seconded by Councilman Merida. The motion was unanimously approved.
- 9. **Request for reinstatement of alcohol beverage license for:** El Grande Truck General Repairs, Corp., d/b/a El Grande Restaurant, 9101 W. Okeechobee Road, Hialeah Gardens: Owner Abel Marino Marquez, Jose M. Herrera Esq.

Mr. Jose M. Herrera, Esquire was present for the applicant. Mr. Arturo L. Ruiz, Director of Administration came forward and gave recommendations and details of an event that occurred on the premises and provided a police report. The incident did not involve the applicant. Councilman Piña had comments regarding the police report and asked Chief H. Keith Joy to elaborate on the incident. Chief H. Keith Joy came forward and gave details of the statements made by individuals involved in the altercation. Mr. Abel Marino Marquez, the owner was present and Chairman Garcia asked if his establishment had sold any alcohol. Mr. Marquez answered no and his attorney offered that there was a history of tenant/landlord disputes on the property. He also offered that individuals bought alcohol at other locations and then went to the truck stop to drink. Recommendations were made to the applicant to be more aware of the activities on the premises. Chairman Garcia made a motion to approve with the provision that if another infraction were to occur, there would be severe restrictions on their licensure. The motion was seconded by Councilman Merida and approved unanimously.

10. **Discussion regarding implementation of new guidelines for zoning code:** Mrs. Mirtha Gonzalez, Chief Zoning Official.

Mrs. Mirtha S. Gonzalez, Chief Zoning Official came forward and gave a visual presentation on the new design guidelines for commercial development within the City and a detailed report of the Planning & Zoning Department's recommendations for the new annexation area.

11. Discussion of advertisement for Request for Proposals for loan financing (Road Improvement and Capital Improvement): Mr. Marcos Piloto, O.M.B. Director.

Mr. Marcos Piloto, Director of O.M.B. came forward and gave a report regarding the Requests for Proposals for the financing of a loan for the Five Year Road Improvement Plan which will be funded by the surtax on gasoline monies from Miami-Dade County. The surtax monies will also fund the transit system for the City. The other Request for Proposals was for the infrastructure plan for a loan not to exceed \$5,050,000.00 for the building of various departments on the acquired ten and one half acres of land adjacent to the Westland Gardens Park. The plan includes a police substation, the Water & Sewer Department, a maintenance facility, a recreation center and banquet hall with a terrace, a second story for City Hall, a retrofit cafeteria roof extension, racquetball and squash courts. The bank loan will be based on a ten-year period with a twenty-year amortization schedule with approximate annual payments. The first twelve months will only be interest payment. The payment plan will consist of charging the Water & Sewer Department for their prorated share of the government complex, which will cover the first three and one half years of the loan. It also plans to dedicate all impact fees associated with construction of the acquired annexation area to make payment for the remaining term of the loan. Chairman Garcia made a motion to approve advertising for Request for Proposals for loans, seconded by Councilman Merida, and was unanimously approved.

12. Discussion of E-Surplus Auction System: Mr. Marcos Piloto, O.M.B. Director.

Mr. Marcos Piloto, Director of O.M.B. came forward and gave information regarding the E-Surplus Auction System. This system will allow the City to auction outdated or unused equipment via the internet and is more feasible than holding a private auction.

13. **Proposed Resolution:**

A) A RESOLUTION OF THE CITY OF HIALEAH GRDENS, FLORIDA, APPROVING THE RENEWAL OF THE AGREEMENT BETWEEN THE DEPARTMENT OF TRANSPORTATION, STATE OF FLORIDA, AND THE CITY OF HIALEAH GARDENS CONCERNING TURF AND LANDSCAPE MAINTENANCE; PROVIDING FOR SEVERABILITY; AND PROVIDING FOR AN EFFECTIVE DATE.

Mr. Citrin read the full resolution into the record. Mrs. Aida Martinez Ruiz, Assistant City Attorney came forward and explained the details of the renewal contract with the Florida Department of Transportation regarding the turf and landscape maintenance agreement. Chairman Garcia made a motion to approve, seconded by Councilman Merida and was approved by unanimously consent.

14. Second Reading / Public Hearing for consideration and final adoption of the following ordinances:

Mr. Citrin read the full title of the ordinance into the record. Mr. Cory Collins, Esquire was present for the applicant. Mrs. Mirtha S. Gonzalez, Chief Zoning Official came forward and gave recommendations regarding the name change for the final plat. The change had been requested by Miami-Dade County. Chairman Garcia opened the public hearing at 8:35 p.m. No one came forward; Chairman Garcia closed the public hearing

at 8:35 p.m. Chairman Garcia made a motion to approve, seconded by Councilman Merida and unanimously approved by individualized voice vote (**Vote 5-0**).

Mr. Citrin read the full title of the ordinance into the record. Ms. Amy Khamissian was present for the applicant. Mrs. Mirtha S. Gonzalez, Chief Zoning Official came forward and gave recommendations from the City, Miami-Dade County, Florida Department of Community Affairs, and the Miami-Dade County School Board, which were all favorable. This ordinance will serve to adopt and formalize the Department of Community Affairs' requirements. Chairman Garcia opened the public hearing at 8:38 p.m. No one came forward; Chairman Garcia closed the public hearing at 8:38 p.m. Chairman Garcia made a motion to approve, seconded by Councilman Merida and unanimously approved by individualized voice vote (Vote5-0).

- 15. **City Attorney's Report:** Mr. Citrin reported on the disciplinary actions in the Police Department regarding the Rivero case, thanked Chief H. Keith Joy, and commended J. Frost Walker III and Aida Martinez Ruiz for their work on the case.
- 16. **Mayor's Report Miscellaneous:** The Mayor commended Arturo L. Ruiz for his work on the Brothers to the Rescue dedication and also commended Aida Martinez

Ruiz for preparing the programs for the event. The Mayor stated his pride for the work of the City Council members and staff regarding the City's annexation. He also mentioned the new programs that have been added to the Parks & Recreation Department which include dance, tennis, soccer, basketball, and flag football. The Mayor also reminded of the Mother's Day celebration to be held at the senior center on Friday, May 7th.

17. Council Members Concerns/Reports – Miscellaneous:

Councilman Gutierrez commended the Mayor and the City for the reconstruction of the sidewalks on 80th Court. He also complimented Marcos Piloto and Mirtha S. Gonzalez for their presentations. There were no further comments.

18. **Adjournment:** The meeting was adjourned at 8:47 p.m.
