- 1. Call to Order: Vice Chairman Piña called the meeting to order at 7:40 p.m.

Mr. Piloto is recommending the waiving of competitive bidding due to time restraints and that it would be in City's best interest at this time to extend the contract with Averett, Warmus, Durkee, Bauder, Thompson. Vice Chairman Piña made a motion to approve, seconded by Councilman Merida and unanimously approved.

Based on her recommendation to award the contract to Construction Catering, Inc., which was the only bid received, Vice Chairman Piña made a motion to approve, seconded by Councilman Merida and the motion was unanimously approved.
