CITY COUNCIL MEETING TUESDAY, NOVEMBER 16, 2004

CITY COUNCIL CHAMBERS 10001 NW 87 AVENUE

- 1. **Call to Order:** Chairman Luciano Garcia called the meeting to order 7:38 p.m.
- 2. **Roll Call:** Present were Chairman Luciano Garcia, Councilman Jorge Gutierrez, Councilman Jorge A. Merida and Councilman Manuel Zardon. Also present were Mayor Yioset De La Cruz and City Attorney Charles A. Citrin. Councilman Rolando Piña was absent.
- 3. **Invocation:** Chairman Luciano Garcia led the invocation.
- 4. **Pledge of Allegiance:** Mayor Yioset De La Cruz led the Pledge of Allegiance.
- 5. **Deletions/Emergency Additions:** A resolution approving and ratifying the agreement for renewal of the City's health insurance with Humana was added to the Agenda as Item 10 D.
- 6. **Review of Minutes:** November 2, 2004. Chairman Garcia made a motion to approve the minutes of November 2, 2004, seconded by Councilman Merida. The motion was unanimously approved.
- 7. **Public Comments:** None were offered.
- 8. Appointments to Personnel Review Board: Vice Chairman Rolando Piña.

Chairman Garcia stated that Councilman Piña was unable to attend tonight's meeting, but prepared a memorandum nominating Mr. Raul L. Lafita for appointment to the Personnel Review Board. Chairman Garcia made a motion to ratify Mr. Lafita's appointment, seconded by Councilman Merida and the motion was unanimously approved.

 Approval of Water Extension Agreement between the City of Hialeah Gardens and Felix and Mayra Acosta to serve Lots 6 and & 7 of Forrest Farms Subdivision NW 97 Court and approx. NW 119 Street: Mr. Albert Nielson, Water and Sewer Department Director. Mr. Albert Neilson, Director of the Water and Sewer Department came forward and gave a report on the item and stated that the Water and Sewer Board had reviewed and unanimously approved the agreement. Chairman Garcia made a motion to approve, seconded by Councilman Merida and the motion was unanimously approved.

10. Proposed Resolutions:

A) RESOLUTION OF THE CITY OF HIALEAH GARDENS, FLORIDA, APPROVING THE COLLECTIVE BARGAINING AGREEMENT BETWEEN THE CITY OF HIALEAH GARDENS AND THE POLICE BENEVOLENT ASSOCIATION BEGINNING OCTOBER 1, 2004 UNTIL SEPTEMBER 30, 2007; PROVIDING FOR IMPLEMENTATION OF SUCH CONTRACT; PROVIDING FOR EFFECTIVE DATE.

Mr. Citrin read the full title of the resolution into the record. Mrs. Aida Martinez came forward and gave a report on the agreement between the Police Benevolent Association and the City. Chairman Garcia made a motion to approve, seconded by Councilman Merida and the motion was unanimously approved.

B) RESOLUTION OF THE CITY OF HIALEAH GARDENS, FLORIDA, AUTHORIZING THE CITY TO COMPENSATE POLICE DISPATCHERS AT AN OVERTIME RATE FOR HOLIDAYS WORKED REGARDLESS OF THE NUMBER OF HOURS WORKED DURING THE WEEK; PROVIDING FOR CONFLICTS; PROVIDING FOR SEVERABILITY; AND PROVIDING FOR AN EFFECTIVE DATE.

Mr. Citrin read the full title of the resolution into the record. Mrs. Aida Martinez came forward and stated that this resolution will serve to memorialize the policies that are currently in place for the police dispatchers. Chairman Garcia made a motion to approve, seconded by Councilman Merida and the motion was unanimously approved.

C) RESOLUTION OF THE CITY OF HIALEAH GARDENS, FLORIDA AUTHORIZING ENTERING INTO A MUTUAL AID AGREEMENT WITH MIAMI-DADE COUNTY. **FLORIDA** REGARDING **ENFORCEMENT ISSUES** AND**NEEDS:** AUTHORIZING THE EXECUTION OF SUCH AGREEMENT BY THE MAYOR; RATIFYING THE PROVISIONS OF SUCH AGREEMENT; PROVIDING FOR CONFLICTS; PROVIDING FOR SEVERABILITY; AND PROVIDING FOR AN EFFECTIVE DATE.

Mr. Citrin read the full title of the resolution into the record. Chief H. Keith Joy came forward and stated that this is a renewal of the Mutual Aid Agreement with Miami-Dade County. Chairman Garcia made a motion to approve, seconded by Councilman Merida and the motion was unanimously approved.

D) RESOLUTION OF THE CITY OF HIALEAH GARDENS, FLORIDA APPROVING AND RATIFYING THE AGREEMENT FOR RENEWAL OF THE CITY'S HEALTH INSURANCE BETWEEN HUMANA AND THE CITY OF HIALEAH GARDENS; PROVIDING FOR SEVERABILITY; AND PROVIDING FOR EFFECTIVE DATE.

Mr. Citrin read the full title of the resolution into the record. Mrs. Aida Martinez came forward and gave information regarding the renewal of the City employees' health insurance. Brown & Brown agent, Mr. Alex Guerra, was present and had obtained numerous quotes for coverage. After review of the proposals, it was determined that Humana was the most beneficial for the employees and was selected. Chairman Garcia made a motion to approve, seconded by Councilman Merida and the motion was unanimously approved.

Chairman Garcia stated that this was a first reading and as such, an opportunity for public input would be provided upon second reading. Councilman Merida made a motion to approve, seconded by Councilman Zardon. The motion was unanimously approved by individualized voice vote (3-1 with Chairman Garcia voting against).

Chairman Garcia opened the public hearing at 8:00 p.m. No one came forward; Chairman Garcia closed the public hearing at 8:00 p.m. A motion to approve was made by Chairman Garcia, seconded by Councilman Merida, and the motion was unanimously approved by individualized voice vote. (4-0).

- 14. **Mayor's Report Miscellaneous:** Mayor De La Cruz stated that he would report on future City projects at the next council meeting.
