## **MINUTES**

CITY COUNCIL MEETING TUESDAY, MAY 20, 2003

CITY HALL COUNCIL CHAMBERS 10001 N.W. 87 AVENUE

- 1. **Call to Order:** Chairman Garcia called the meeting to order at 7:34 p.m.
- 2. **Roll Call:** Present were Chairman Luciano Garcia, Councilman Manuel Zardon, Councilman Jorge Merida and Councilman Jorge Gutierrez. Also present were Mayor Yioset De La Cruz and City Attorney Charles A. Citrin.
- 3. **Invocation:** Chairman Garcia gave the invocation.
- 4. **Pledge of Allegiance:** Mayor De La Cruz led the Pledge of Allegiance.
- 5. **Deletions/Emergency Additions:** A request to advertise for proposals for Evaluation and Appraisal Report (E.A.R.) Consultant Services was added to the agenda as **Item 6a.**
- 6. **Review of Minutes: May 6, 2003:** Chairman Garcia made a motion to approve the minutes of May 6, 2003, seconded by Councilman Zardon. The motion passed by unanimous consent.
- 6a. Request for proposals for Evaluation and Appraisal Report (E.A.R.) Consultant Services: Mirtha Gonzalez, Chief Zoning Official came forward and gave an explanation for the need to advertise for consultant services to prepare the City's E.A.R. The Evaluation and Appraisal Report is a summary audit of the progress made in implementing a local government's Comprehensive Plan and is done every seven years. Chairman Garcia made a motion to approve, seconded by Councilman Zardon. The motion was unanimously approved.

Mr. Citrin read the full title of the resolution into the record. Chairman Garcia stated that this resolution served to memorialize the action taken by the Council at their last meeting and offered a motion to approve. Councilman Zardon seconded the motion and it was unanimously approved.

Following Councilman Gutierrez's statement, Mirtha Gonzalez, Chief Zoning Official, was asked to come forward and give staff recommendations on the ordinance at hand. Chairman Garcia opened the public hearing for discussion on the item at 7:41 p.m. As no one offered testimony, he closed the public hearing at 7:41 p.m. and made a motion to approve. The motion was seconded by Councilman Merida with Councilman Zardon voting in favor and Councilman Gutierrez abstaining. (Vote 3-0)

The motion was seconded by Councilman Merida with Councilman Zardon voting in favor and Councilman Gutierrez abstaining. (Vote 3-0)
