MINUTES

CITY COUNCIL MEETING TUESDAY, JUNE 3, 2003

CITY HALL COUNCIL CHAMBERS 10001 N.W. 87 AVENUE

- 1. **Call to Order:** Chairman Garcia called the meeting to order at 7:31 p.m.
- 2. **Roll Call:** Present were Chairman Luciano Garcia, Councilman Jorge Merida, Councilman Manuel Zardon, Councilman Rolando Piña and Councilman Jorge Gutierrez. Also present was City Attorney Charles A. Citrin. Mayor De La Cruz joined the meeting at 8:58 p.m.
- 3. **Invocation:** Chairman Garcia gave the invocation.
- 4. **Pledge of Allegiance:** Councilman Piña led the Pledge of Allegiance.
- 5. **Deletions/Emergency Additions:** The opening of sealed bids for Uniform Cleaning Services BID #03-05 was added to the agenda as **Item 7A.**
- 6. **Review of Minutes: May 20, 2003**: Chairman Garcia made a motion to approve the minutes of May 20, 2003, seconded by Councilman Zardon. The motion passed by unanimous consent.
- 7. Presentation of proposals received for City employee's Dental Insurance coverage: Aida Martinez, Director of Personnel, summarized her review of the proposals received for dental coverage. Based on her review Ms. Martinez made a recommendation to enter into an agreement with Cigna which was offering a better rate than the existing policy with Guardian. Chairman Garcia made a motion to approve the recommendation, a second was offered by Councilman Merida and the motion passed by unanimous consent.
- 7a. **Opening of sealed bids for Uniform Cleaning Services BID #03-05:** Marcos Piloto, Director, O.M.B., publicly opened the two sealed bids that were received. The bids were as follows:

UniFirst Corporation, weekly charge of \$4.15 per employee. Spirit Services, Co., weekly charge of \$4.75 per employee. Mr. Piloto requested the opportunity to review the proposals and make a recommendation at the next Council meeting.

8. Proposed Resolutions:

A) A RESOLUTION OF THE CITY OF HIALEAH GARDENS AUTHORIZING THE MAYOR TO EXECUTE AN INTERLOCAL AGREEMENT WITH MIAMI-DADE COUNTY FOR THE DISTRIBUTION OF CHARTER COUNTY TRANSIT SYSTEM SURTAX PROCEEDS LEVIED BY MIAMI-DADE COUNTY ATTACHED HEREIN AS EXHIBIT "A"; PROVIDING FOR SEVERABILITY; PROVIDING FOR EFFECTIVE DATE.

Mr. Citrin read the full title of the resolution into the record. Marcos Piloto, Director, O.M.B. spoke to the issue of the interlocal agreement that would allow the City to receive a portion of the Charter County Transit System Surtax proceeds from Miami-Dade County. Chairman Garcia made a motion to approve, seconded by Councilman Gutierrez. The motion passed by unanimous consent.

B) A RESOLUTION OF THE CITY OF HIALEAH GARDENS AUTHORIZING THE MAYOR TO EXECUTE AN AGREEMENT WITH UNION PLANTERS BANK FOR AN AUTOMATED INVESTMENT SWEEP ACCOUNT AND MASTER REPURCHASE AGREEMENT ATTACHED HEREIN AS EXHIBIT "A"; PROVIDING FOR SEVERABILITY; PROVIDING FOR EFFECTIVE DATE.

Mr. Citrin read the full title of the resolution into the record. Marcos Piloto, Director, O.M.B. came forward and gave a report regarding the City investing in an overnight repurchase agreement. The issue was discussed with First Southwest Company, the City's financial advisors who agreed that this type of investment would be the most secure. Chairman Garcia made a motion to approve, seconded by Councilman Merida. The motion passed by unanimous consent.

- 9. Second Reading/Public Hearing for consideration and final adopting of the following ordinances: At this time the City Attorney swore in those individuals who would be offering testimony on any of the items for public hearing.

Mr. Citrin read the full title of the ordinance into the record. Councilman Gutierrez took this opportunity to abstain from voting on the public hearing items due to his participation on the Planning and Zoning Board. Mr. Bruce Smoler was present for the applicant. Mirtha Gonzalez, Chief Zoning Official came forward and offered a description and staff recommendations on the project. Chairman Garcia opened the public hearing at 7:46 p.m. for discussion on the item. The following individuals addressed the Council:

No further testimony was forthcoming therefore Chairman Garcia closed the public hearing at 7:53 p.m. Mr. Bruce Smoler came forward and offered additional information regarding the project. Chairman Garcia stated that the issue at hand was approval of the final plat and that the applicant had met all technical requirements. Based on this determination, Chairman Garcia made a motion to approve, seconded by Councilman Zardon. The motion passed unanimously by individualized voice vote, with Councilman Gutierrez abstaining. (Vote 4-0)

Mr. Citrin read the full title of the resolution into the record. Mr. Mario Ferro, the applicant and Mr. Octavio Santurio, architect for the project were present. Mirtha Gonzalez came forward and gave a description of the project and staff recommendations. Chairman Garcia opened the public hearing at 8:06 p.m. The following individual came forward to address the Council:

The motion was unanimously approved by individualized voice vote with Councilman Gutierrez abstaining. (Vote 4-0)

Mr. Citrin read the full title of the ordinance into the record. Mr. Alexis Ramos, the applicant was present. Mirtha Gonzalez, Chief Zoning Official gave staff recommendations for approval of the waiver of plat. Chairman Garcia opened the public hearing for discussion on the item at 8:13 p.m. As no one came forward, he closed the hearing at 8:13 p.m. and offered a motion to approve. The motion was seconded by Councilman Merida and unanimously approved by individualized voice vote with Councilman Gutierrez abstaining. (Vote 4-0)

Chairman Garcia opened the public hearing for discussion on the item at 8:16 p.m. The following individual addressed the Council:

Mr. Citrin read the full title of the ordinance into the record. Mr. John Nagelis was present for the applicant. Mirtha Gonzalez, Chief Zoning Official, explained that the application for final plat had been reviewed and deficiencies had been found. Mrs. Gonzalez asked that the item be tabled in order to allow the surveyor time to correct the discrepancies. Based on this information, Chairman Garcia made a motion to table the item, seconded by Councilman Merida. The motion was unanimously approved by individualized voice vote with Councilman Gutierrez abstaining. (Vote 4-0 Tabled)

Mirtha Gonzalez, Chief Zoning Official came forward and stated that this was a tentative plat application with no variances and gave staff recommendations. Chairman Garcia opened the public hearing for discussion on the item at 8:21 p.m. No one came forward to speak on the issue, therefore he closed the public hearing at 8:21 p.m. and offered a motion to approve. Councilman Merida seconded the motion and it was unanimously approved by individualized voice vote with Councilman Guttierez abstaining. (Vote 4-0)

A five-minute recess was called at 8:23 p.m. and the meeting reconvened at 8:28 p.m.

- 12. **City Attorney's Report:** Mr. Citrin reported that the City had argued the Machado case in the Third District Court and that an opinion would be forthcoming. He also reported that the City had no further liability in the Thunderwheels case as it had been negotiated out with the City's insurance company. Mr. Citrin also commented on the possibility of a lawsuit by Cigarette Racing LLC.
- 13. **Mayor's Report Miscellaneous -** Mayor De La Cruz commented on the various ongoing projects in the City including landscaping, road improvements, and the commencement of the Hydra-Villas project. He also reported that the auditors had made favorable remarks regarding the City's sound financial state. In closing the Mayor stated that he welcomed comments, both positive and negative, from the all the City's residents, but he is confident that a majority of the residents are pleased with the good work and progress being made by the present City administration.

He stated that he would keep this in mind when weighing the validity of these comments and asked everyone to do the same.
