MINUTES CITY COUNCIL MEETING TUESDAY, DECEMBER 2, 2003

CITY COUNCIL CHAMBERS 10001 NW 87 AVENUE

- 1. **Call to Order:** Chairman Garcia called the meeting to order at 7:34 p.m.
- 2. **Roll Call:** Present were Chairman Luciano Garcia, Councilman Manuel Zardon , Councilman Jorge Merida, and Councilman Rolando Piña. Also present were City Attorney Charles A. Citrin and Mayor Yioset De La Cruz.
- 3. **Invocation:** Chairman Garcia gave the invocation.
- 4. **Pledge of Allegiance:** Councilman Rolando Piña led the Pledge of Allegiance.
- 5. **Deletions/Emergency Additions:** None were offered.
- 6. **Review of Minutes:** November 18, 2003: Chairman Garcia made a motion to approve the minutes of November 18, 2003, seconded by Councilman Merida. The motion was approved by unanimous consent.
- 7. **Public Comments:** The following individual came forward and addressed the Council Mr. Russell Fai, 13500 NW 97 Avenue, Hialeah Gardens. Mr. Joe Lopez, Public Works Director addressed the issue brought forward by Mr. Fai.
- 8. Recommendation on bids received for City employee's health insurance coverage:
 Mrs. Aida Martinez-Ruiz, Director of Personnel gave a report on proposals received and recommended to change from Aetna to Humana who quoted a lower rate. Humana quoted two brokers; one came in lower (Brown & Brown) all brokers were present at the Council Meeting. A resolution had been prepared recommending Humana.
 - A) A RESOLUTION OF THE CITY OF HIALEAH GARDENS, FLORIDA APPROVING AND RATIFYING THE AGREEMENT FOR THE CITY'S MEDICAL HEALTH INSURANCE BETWEEN HUMANA AND THE CITY OF HIALEAH GARDENS, PROVIDING FOR EFFECTIVE DATE

Mr. Citrin read the full title of the resolution into the record. The staff was instructed to meet with the brokers and work out the details. Chairman Garcia made a motion to approve, seconded by Councilman Merida. The motion was approved by unanimous consent.

9. Opening of sealed bids for construction of cafeteria and roof extension and structure for squash and racquetball courts at Westland Gardens Park: Mr. Raymond Garcia, Director of Parks and Recreation, publicly opened the three sealed bids that were received. The bids were as follows:

Mr. Citrin read the full title of the ordinance into the record. Mr. Bernie Maribona, the applicant was present. Mrs. Mirtha Gonzalez, Chief Zoning Official came forward and gave staff recommendations. Chairman Garcia opened the hearing for discussion of the item at 7:52 p.m. No testimony was offered; therefore, Chairman Garcia closed the public hearing at 7:52 p.m. A motion to approve was made by Chairman Garcia, seconded by Councilman Merida, and unanimously approved by individualized voice vote (Vote 4-0).

Mr. Citrin read the full title of the ordinance into the record. Mr. Stanley Price and Mr. BillRiley, Jr. were present for the applicant. Mrs. Mirtha Gonzalez, Chief Zoning Official came forward and gave staff recommendations. Mr. Price came forward and gave a presentation, which provides for a covenant running with the land providing for a land use amendment to provide up to 60 units. Chairman Garcia noted for the record that Councilman Gutierrez joined the proceedings at 8:00 p.m. Mr. Price continued with his presentation and offered to remove Track 22 and Track 23 from the application in order to lower units and to develop ten acres at this time rather than thirty acres. Mr. J. C. Alvarez, the applicant came forward and gave his comments on the project stating that Tracks 22 and 23 would remain acre and one-quarter lots. Mr. Price resumed his presentation. Mr. Andy Doyle Carr, Miami Economic Associates came forward and discussed analysis regarding absorption of one and one quarter acre lots and gave recommendations for Track 24 to be developed with smaller lots. Mr. Doyle Carr detailed his experience and offered his biography and education. Mr. Price noted that the proposed project would be reduced from 60 units on thirty acres to 44 units, 8 on Track 22, 8 on Track 23, and 28 on Track 24. Chairman Garcia opened the public hearing at 8:27 p.m. and called for a recess of five minutes at 8:28 p.m. The meeting was reconvened at 8:37 p.m.

Chairman Garcia closed the public hearing at 9:35 p.m. Mr. Price was given the opportunity for rebuttal of those who testified and explained the nature of the application, which is a request to transmit a land use amendment to the Comprehensive Plan. Mr. Price will agree not to modify Tracks 22 and 23 and will agree to square footage of homes. Mr. J. C. Alvarez, the applicant came forward again and made further comments regarding an improved application with respect to compatibility. Chairman Garcia made positive comments regarding the applicant and his efforts to amend his application. He noted however his reluctance to change the Estates area zoning and then made a motion to deny the application. No second was offered. Each Council member made individual comments on the project. Chairman Garcia once again made a motion to deny the application, seconded by Councilman Gutierrez, and unanimously denied by the Council by individualized voice vote (Vote 0-5).

Chairman Garcia called a recess at 10:05 p.m. The meeting was reconvened at 10:10 p.m.

Mr. Citrin read the full title of the ordinance into the record. Mrs. Mirtha Gonzalez, Chief Zoning Official gave the project description and staff recommendations. Ms. Amy Khamissian, the applicant gave a presentation on the project, which would provide for 92 units and will proffer a covenant with the land to comply with the conditions of the Planning & Zoning Board (92 units and water and sewer connections). Ms. Khamissian also noted that she has met with the Miami-Dade School Board and discussed the proposed impact of the project. She also discussed issues of traffic, and mentioned that she had met with Mr. Albert Neilson, Department of Water & Sewer Director, regarding water and sewer availability. Chairman Garcia opened the public hearing at 10:21 p.m.

The following individual addressed the Council:

No further testimony was offered. Chairman Garcia closed the public hearing at 10:27 p.m. Ms. Khamissian came forward and offered her rebuttal of the testimony given. Chairman Garcia gave his comments regarding requests for land use amendments to change zoning from Business Use to Medium Density. He stated his reluctance to

change the use and to keep the tracks uniform. Mayor De La Cruz made positive comments regarding the project. Councilman Merida and Councilman Gutierrez also made positive remarks. A motion to approve was made by Councilman Merida with a condition of a covenant for only 92 units, seconded by Councilman Zardon. Councilman Gutierrez voted in favor with Chairman Garcia and Councilman Piña voting against. The motion was approved. (Vote 3-2).

Chairman Garcia made a motion to transmit the application to the Department of Community Affairs, seconded by Councilman Zardon, and unanimously approved by individualized voice vote (Vote 5-0).

- 11. **City Attorney's Report-** No comments were offered. A copy of the Florida Municipal Law Reporter was handed out with the Machado opinion.
- 12. **Mayor's Report Miscellaneous** Mayor De La Cruz congratulated Councilman Gutierrez for getting 71 % of the vote. He acknowledged complaints made against plastic flowers planted in front of a home in the Estates area and is looking into it.
- 13. Council Members Concerns/Reports Miscellaneous -

Councilman Jorge Gutierrez apologized for his appearance and for arriving late. He was not feeling well.

Councilman Jorge Merida ceded his time to Mr. Juan Gonzalez, 9990 NW 130 Street , Hialeah Gardens. Mr. Gonzalez voiced his concerns regarding the speed limit not being posted on 131 Street between 99 Avenue and 102 Avenue. Chief Joy made comments on the issue.

Councilman Zardon asked Councilman Piña how many houses did he want in the Estates regarding the previous application. Councilman Piña replied that he will make a decision when an actually proposal is before him.

Councilman Piña hoped he responded to Councilman Zardon to his satisfaction and expressed of how different they were and how well they work together.

14. **Adjournment:** The meeting was adjourned at 10:57 p.m.
