MINUTES

CITY COUNCIL MEETING TUESDAY, SEPTEMBER 16, 2003

CITY HALL COUNCIL CHAMBERS 10001 N.W. 87 AVENUE

- 1. **Call to Order:** Chairman Garcia called the meeting to order at 7:36 p.m.
- 2. **Roll Call:** Present were Chairman Luciano Garcia, Councilman Jorge Merida, Councilman Manuel Zardon, Councilman Rolando Piña and Councilman Jorge Gutierrez. Also present was City Attorney Charles A. Citrin.
- 3. **Invocation:** Chairman Garcia gave the invocation.
- 4. **Pledge of Allegiance:** Councilman Piña led the Pledge of Allegiance.
- 5. **Deletions/Emergency Additions:** An ordinance approving a final plat for Emerald Plaza-Ferro Development for second reading (Tabled on 9-04-03) was added to the agenda as Item 11G. Items 11 A-G were tabled due to additional notice requirements.
- 6. **Review of Minutes: September 4, 2003:** Chairman Garcia made a motion to approve the minutes of September 4, 2003, seconded by Councilman Merida. The motion passed by unanimous consent.
- 7. **Public Comments:** The following individuals came forward to address the Council: Mrs. Gerri Fontanella, 13425 N.W. 102 Avenue, Hialeah Gardens, Florida.
- 8. **Recommendation on Bid No. #03-08 Waste Collection and Recycling Bins and Receptacles:** Mr. Marcos Piloto, O.M.B. Director reported on the proposal received from LNC Government Relations and gave his recommendation. He also stated that as part of the agreement, the City would determine all advertising to be displayed on collection receptacles. Chairman Garcia made a motion to approve the recommendation, seconded by Councilman Merida. The motion passed by unanimous consent.

9. **Proposed Resolutions:**

A) RESOLUTION OF THE CITY OF HIALEAH GARDENS AUTHORIZING THE CONSTRUCTION OF N.W. 133RD STREET BETWEEN 98TH AND 102ND AVENUE; AUTHORIZING THE INSTALLATION OF A RETENTION SWALE AND THE CONSTRUCTION OF 2,000 LINEAR FEET OF ROADWAY IN THE AMOUNT OF \$82,210.00; WAIVING COMPETITIVE BIDDING FOR THE PAVING PORTION OF THE PROJECT NOT TO EXCEED \$22,050.00; PROVIDING FOR CONFLICTS; PROVIDING FOR SEVERABILITY; AND PROVIDING FOR EFFECTIVE DATE.

Mr. Citrin read the full title of the resolution into the record. Chairman Garcia stated that this resolution served to memorialize the action taken by the Council at the last meeting and made a motion to approve. Councilman Merida offered a second, and the motion passed by unanimous consent.

Mr. Citrin read the full title of the ordinance into the record. Ms. Jane Storm, surveyor for the project was present for the applicant. Mr. Citrin read the full title of the ordinance into the record. Mr. Michael Osman, the applicant was present. A motion to approve on first reading was made by Councilman Gutierrez, seconded by Councilman Zardon. Chairman Garcia, Councilman Piña and Councilman Merida voted against. (Vote 2-3 Denied). Chairman Garcia, on the prevailing side, offered a motion to reconsider the item and have a public hearing at this time, seconded by Councilman Merida, and unanimously approved by individualized voice vote. (Vote 5-0 to Reconsider Item) Mr. Citrin swore in those individuals who wished to provide testimony on the item. Mrs. Mirtha Gonzalez, Chief Zoning Official, came forward and gave a description of the project and committee recommendations. Mr. Osman was allowed to make his presentation, however he stated that he was unprepared at this time and did not have witnesses present who would testify to the merits of his project. After discussion a motion was made by Councilman Merida to approve the ordinance on first reading, seconded by Councilman Gutierrez. Councilman Zardon and Councilman Piña both voted in favor with Chairman Garcia voting against. (Vote 4-1 Approve on
