## MINUTES

CITY COUNCIL MEETING TUESDAY, OCTOBER 7, 2003

CITY HALL COUNCIL CHAMBERS 10001 NW 87 AVENUE

- 1. **Call to Order:** Chairman Garcia calls the meeting to order at 7:30 p.m.
- 2. **Roll Call:** Present were Chairman Luciano Garcia, Councilman Jorge Merida, Councilman Rolando Piña and Councilman Jorge Gutierrez. Also present was City Attorney Charles A. Citrin.
- 3. **Invocation:** Chairman Garcia gave the invocation.
- 3. **Pledge of Allegiance:** Councilman Piña led the Pledge of Allegiance.
- 4. **Deletions/Emergency Additions:** None were offered.
- 5. **Review of Minutes: September 16, 2003 and September 19, 2003**: Chairman Garcia made a motion to approve the minutes of September 16, 2003 and September 19, 2003, seconded by Councilman Merida. The motion was approved by unanimous consent.
- 6. **Public Comments:** The following individuals came forward to address the Council: Mrs. Gerri Fontanella, 13425 NW 102 Avenue Hialeah Gardens, Florida.
- 8. **Appointment of representative for Election Canvassing Board:** Mr. Charles A. Citrin, City Attorney and the Council discussed the issue and recommended to stay the course for the Canvassing Board in the upcoming election.
- 9. **Proposed Resolutions:** 
  - A) A RESOLUTION OF THE CITY OF HIALEAH GARDENS AUTHORIZING THE ENTERING INTO A TEMPORARY LICENSE AGREEMENT WITH LNC GOVERNMENT RELATIONS FOR TEN (10) WASTE CONTAINERS WITH

SPACE FOR ADVERTISING TO BE PLACED IN DIFFERENT AREAS AROUND THE CITY; AUTHORIZING THE APPROPRIATE CITY OFFICIALS TO EXECUTE AN AGREEMENT WITH LNC GOVERNMENT RELATIONS; PROVIDING FOR CONFLICTS; PROVIDING FOR SEVERABILITY; AND PROVIDING FOR AN EFFECTIVE DATE.

Mr. Citrin read the full title of the resolution into the record. Chairman Garcia stated that this resolution served to memorialize the action taken by the Council at the last meeting and made a motion to approve. Councilman Merida offered a second, and the motion passed by unanimous consent.

B) A RESOLUTION OF THE CITY OF HIALEAH GARDENS AUTHORIZING THE MAYOR TO EXECUTE A RETAINER AGREEMENT BETWEEN CHARLES A. CITRIN, ESQUIRE AND THE CITY OF HIALEAH GARDENS, ATTACHED HERETO AS EXHIBIT "A"; PROVIDING FOR EFFECTIVE DATE.

Mr. Citrin read the full title of the resolution into the record. Chairman Garcia stated that this resolution served to execute the provision for said agreement as adopted in the FY 2003-2004 budget. He then made a motion to approve, seconded by Councilman Merida and the motion was passed by unanimous consent.

## 10. First Reading for consideration of the following ordinance:

A) ORDINANCE OF THE MAYOR AND THE CITY COUNCIL. AMENDING ORDINANCE 2002-51 INITIATING AND REOUESTING A PROPOSED BOUNDARY CHANGE OF THE CITY OF HIALEAH GARDENS, FLORIDA, IN ORDER TO ANNEX PROPERTY BEARING THE AMENDED LEGAL DESCRIPTION CONTAINED IN COMPOSITE EXHIBIT "1"; AUTHORIZING THE MAYOR AND THE CITY CLERK AND OTHER PROPER CITY OFFICERS AND OFFICIALS TO TAKE ANY AND ALL ACTIONS AS MAY BE NECESSARY TO SUBMIT A REQUEST FOR THE PROPOSED BOUNDARY CHANGE TO THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, AND AUTHORIZING THE CITY CLERK TO TRANSMIT COPIES OF THIS ORDINANCE TO THE CLERK OF THE COMMISSION REPEALING ALL ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT HEREWITH; PROVIDING FOR A SEVERABILITY CLAUSE; AND PROVIDING FOR AN EFFECTIVE DATE.

Mr. Citrin read the full title of the ordinance into the record. Chairman Garcia stated that this was a first reading for the record, and as such an opportunity for public input would be provided upon second reading. The Chair made a motion to approve, seconded by Councilman Merida. The motion was unanimously approved by individualized vote. (Vote 4-0)

Mr. Citrin read the full title of the ordinance into the record. Ms. Jane Storms, Surveyor was present for the applicant. Mirtha Gonzalez, Chief Zoning Official, came forward and gave staff recommendations followed by a presentation by Jane Storms without any changes from Tentative Plat. Chairman Garcia opened the public hearing for discussion on the item at 7:42 p.m. As no one came forward, he closed he hearing at 7:42 pm. and offered a motion to approve. The motion was seconded by Councilman Merida and unanimously approved by individualized vote. (Vote 4-0)

Mirtha Gonzalez, Chief Zoning Official gave staff recommendations. Mr. Leach came forward and gave a presentation. Chairman Garcia opened the public hearing for discussion on the item at 7:46 p.m. No one came forward therefore he closed the hearing at 7:46 p.m. Chairman Garcia offered a motion to approve seconded by Councilman Merida and unanimously approved by individualized voice vote. (Vote 4-0)

Mr. Citrin read the full title of the ordinance into the record. Mr. Bernie Maribona was present for the applicant. Mirtha Gonzalez, Chief Zoning Official, came forward with staff recommendations. Chairman Garcia noted that the site plan with the provision for 17 additional parking spaces would have to come before the Council for review and approval and be noticed accordingly.
