CITY COUNCIL MEETING WEDNESDAY, NOVEMBER 5, 2003

CITY COUNCIL CHAMBERS 10001 NW 87 AVENUE

- 1. Call to Order: Chairman Garcia called the meeting to order at 7:38 p.m.
- 2. Roll Call: Present were Chairman Luciano Garcia, Councilman Jorge Merida, Councilman Jorge Gutierrez, Councilman Manuel Zardon, Councilman Rolando Piña. Also present were Mayor Yioset De La Cruz and City Attorney Charles Citrin.
- 3. **Invocation:** Councilman Jorge Gutierrez gave the invocation.
- 4. **Pledge of Allegiance:** Councilman Jorge Gutierrez led the Pledge of Allegiance.
- 5. **Deletions/Emergency Additions:** Chairman Garcia suggested, with no objections to move Item 6, Item 7, and Item 8 behind Item 10.
- 6. **Review of Minutes:** October 21, 2003: Chairman Garcia made a motion to approve the minutes of October 21, 2003, seconded by Councilman Merida. The motion passed by unanimous consent of the Council.
- 7. **Public Comments:** The following individuals came forward to address the Council: Jorge Gutierrez, 10090 NW 80 Ct. Hialeah Gardens, FL as interpreter for Evaristo Zafra, 8090 NW 99 Ln. Hialeah, FL
- 8. Request for approval of 2COP alcohol beverage license, El Grande Truck General Repairs, Corp., d/b/a El Grande Restaurant, 9101 W. Okeechobee Road: Owner: Abel Marino Marquez.
 - Mr. Abel Marquez, Owner was present. Menace Rodriguez, License Director came forward and gave his recommendations. Chairman Garcia made a motion to approve, seconded by Councilman Merida. The motion was unanimously approved.
