CITY COUNCIL MEETING TUESDAY, DECEMBER 16, 2003

CITY COUNCIL CHAMBERS 10001 NW 87 AVENUE

- 1. Call to Order: Chairman Garcia called the meeting to order at 7:37 p.m.
- 2. **Roll Call:** Present were Chairman Luciano Garcia, Councilman Jorge Gutierrez, Councilman Rolando Piña, and Councilman Manuel Zardon. Also, present were City Attorney Charles A. Citrin and Mayor Yioset De La Cruz.
- 3. **Invocation:** Chairman Luciano Garcia gave the invocation.
- 4. **Pledge of Allegiance:** Mayor Yioset De La Cruz led the Pledge of Allegiance.
- 5. **Deletions/Emergency** Additions: None were offered.
- 6. **Review of Minutes:** December 2, 2003: Chairman Garcia made a motion to approve the minutes of December 2, 2003, seconded by Councilman Zardon. The motion was approved by unanimous consent.
- 7. **Public Comments:** The following individual came forward to address the Council:

8. Request for approval of refund for Local Law Enforcement Block Grant to the Office of Justice Programs: Mr. Marcos Piloto, O.M.B. Director.

Mr. Marcos Piloto, O.M.B. Director and Mr. H. Keith Joy, Chief of Police came forward and explained the particulars regarding the refund for the grant monies expended by the Department of Justice. Chairman Garcia made a motion to approve, seconded by Councilman Zardon. The motion was unanimously approved.

9. **Proposed Resolution:**

Mr. Citrin read the full title of the resolution into the record. Mr. Marcos Piloto, O.M.B. Director came forward and gave a report on the purchase of two dump trucks. A motion to approve was made by Chairman Garcia, seconded by Councilman Zardon, and unanimously approved by voice vote.

Director came forward and gave a presentation regarding the benefits of an interlocal agreement with the City of Hialeah transit system service. A motion to approve was made by Chairman Garcia, seconded by Councilman Zardon, and unanimously approved by voice vote.
