MINUTES

CITY COUNCIL MEETING TUESDAY, JUNE 18, 2002

CITY HALL COUNCIL CHAMBERS 10001 N.W. 87 AVENUE

- 1. **Call to Order:** Chairperson Garcia called the meeting to order at 7:36 p.m.
- 2. **Roll Call:** Present were Chairperson Garcia and Council members, Lucy Valdes, Miguel Haddad, and Manuel Zardon. Also present were Mayor Yioset De La Cruz and City Attorney Charles A. Citrin.
- 3. **Invocation:** Chairperson Garcia gave the invocation.
- 4. **Pledge of Allegiance:** Mayor De La Cruz led the Pledge of Allegiance.
- 5. Deletions/Emergency Additions: A motion to table Item 9 was made by Chairperson Garcia, seconded by Council member Valdes and unanimously approved. A recommendation for a Dental Insurance provider was added to the agenda as Item 9a. Council member Valdes suggested a change in the order of the agenda by requesting that the first reading of ordinances be taken up before the proposed resolutions in order to accommodate the public.
- 6. **Review of Minutes: June 4, 2002:** Chairperson Garcia made a motion to approve the minutes of June 4, 2002, seconded by Council member Valdes. The motion was approved unanimously.
- 7. Request to waive competitive bidding for purchase of single axle 15,000 lb. GVWR 4 x 2 truck for Public Works Department. Mr. Joe Lopez, Director of Public Works addressed the council and recommended waiving competitive bidding and going forward with the purchase via a State contract. Maroone Chevrolet, an approved contractor under state contract specification #070650010 provided a quote of \$27,084.00. A motion to approve the purchase was made by Chairperson Garcia, seconded by Council member Zardon. The motion was approved unanimously. Mr. Citrin was instructed to prepare a resolution memorializing the action taken.

- 8. Recommendation to award contract for N.W. 80th Avenue (South District) Drainage Improvements project (PW 2002-05): Mr. Joe Lopez, Director of Public Works recommended awarding the contract to Gonzalez Pavement Equipment, Inc. who was the lowest bidder on the project. Chairperson Garcia made a motion to approve, seconded by Council member Zardon. The motion was unanimously approved.
- 9. **Discussion of deposit to City of Hialeah Gardens by Mr. Miguel Haddad:** Mr. Ralph Ventura, Esq. This item was tabled. **(Tabled)**
- 9a. **Recommendation for Dental Insurance provider:** Ms. Aida Martinez, Assistant City Attorney speaking as Director of Personnel, stated that she had received R.F.P's to provide dental insurance coverage for City employees. After a review of the proposals she was recommending the City continue with Guardian, the current provider. Chairperson Garcia made a motion to approve, seconded by Council member Haddad. The motion was approved unanimously.
- 10. **Discussion regarding the City's Comprehensive Plan Amendments:**Mirtha Gonzalez, Chief Zoning Official came forward and explained that Florida Statute 153.3197 allows for two application periods within each year to accept Land Use Amendments to the Comprehensive Plan. The City had only been providing for one. It was Ms. Gonzalez recommendation to advertise for a second filing period in September 2002 allowing for public hearings in December 2002. A motion was made by Chairperson Garcia to permit this as procedure, seconded by Council member Valdes. The motion was unanimously approved.

11. PROPOSED RESOLUTIONS:

A) RESOLUTION OF THE CITY OF HIALEAH GARDENS, WAIVING THE PERMIT AND INSPECTION FEES FOR THE SAMARI LAKES ROOFING PROJECT; PROVIDING FOR CONFLICTS; PROVIDING FOR SEVERABILITY; AND PROVIDING FOR AN EFFECTIVE DATE.

City Attorney Citrin read the full title of the resolution into the record. Mayor De La Cruz stated the provisions of the resolution for waiving of the City's permit and inspection fees. He explained that an amount equal to that of the waived fees will be taken from the monies already collected from the special assessment for roof repairs and applied to Samari Lakes outstanding water and sewer bill. A motion to approve was then made by Council member Haddad seconded by Council member Valdes. The motion was unanimously approved.

B) RESOLUTION OF THE CITY OF HIALEAH GARDENS, SUPPORTING THE RESIDENTS OF SAMARI LAKES IN RE-ESTABLISHING THE CONDOMINIUM ASSOCIATION.

City Attorney Citrin read the full title of the resolution into the record. Mayor De La Cruz explained the resolution which acknowledges the City's support of the efforts by the residents of Samari Lakes to re-establish their condominium association. Chairperson Garcia noted that this resolution would only be stating the opinion of the council and government of Hialeah Gardens and was not a binding document. All final decisions regarding Samari Lakes are made by the Dade County Circuit Court. The following individuals came forward and gave testimony on this item:

Following the testimony, Chairperson Garcia made a motion to approve, seconded by Council member Valdes. The motion was unanimously approved.

City Attorney Citrin read the full title of the ordinance into the record. Mr. Haddad left the dais and came forward as the applicant. Chairperson Garcia stated that this was a first reading and as such, an opportunity for public input would be provided upon second reading. He then made a motion to approve, seconded by Council member Valdes. The motion was unanimously approved by individualized voice vote with Council member Haddad recusing himself and abstaining. (Vote 3-0)

City Attorney Citrin read the full title of the ordinance into the record. Mr. Sergio Ancia, was present for the applicant. Chairperson Garcia stated that this was a first reading and as such, an opportunity for public input would be provided upon second reading. He then made a motion to approve, seconded by Council member Valdes. The motion was unanimously approved by individualized voice vote. (Vote 4-0)

City Attorney Citrin read the full title of the ordinance into the record. Ms. Linda Stein, the applicant, was present. Chairperson Garcia stated that this was a first reading and as such, an opportunity for public input would be provided upon second reading. He then made a motion to approve, seconded by Council member Valdes. The motion was unanimously approved by individualized voice vote. (Vote 4-0)

D) ORDINANCE OF THE CITY OF HIALEAH GARDENS, FLORIDA. GRANTING A SPECIAL EXCEPTION USE TO PERMIT A CHARTER SCHOOL AND SITE PLAN REVIEW FOR MATER ACADEMY CHARTER SCHOOL, CONCERNING PROPERTY ADDRESS: 7901 N.W. 103rd STREET. FOLIO #27-3003-001-0020; PROVIDING FOR EFFECTIVE DATE. (Location: 7901 N.W. 103rd Street) (P&Z 3-0 T.R.C. 6-0)

City Attorney Citrin read the full title of the ordinance into the record. Mr. Fernando Zulueta, the applicant, was present. Chairperson Garcia stated that this was a first reading and as such, an opportunity for public input would be provided upon second reading. He then made a motion to approve, seconded by Council member Valdes. The motion was unanimously approved by individualized voice vote. (Vote 4-0)

Chairperson Garcia called for a recess at 8:37 p.m. The meeting was reconvened At 8:44 p.m.

- 13. PUBLIC HEARING and Second Reading for consideration and final adoption of the following ordinance:
 - A) ORDINANCE ADOPTING AND ENACTING A NEW CODE FOR THE CITY OF HIALEAH GARDENS, FLORIDA; PROVIDING FOR THE REPEAL OF CERTAIN ORDINANCES NOT INCLUDED THEREIN; PROVIDING A PENALTY FOR THE VIOLATION THEREOF; PROVIDING FOR THE MANNER OF AMENDING SUCH CODE; AND PROVIDING WHEN SUCH CODE AND THIS ORDINANCE SHALL BECOME EFFECTIVE.

City Attorney Citrin read the full title of the ordinance into the record. Mari Joffee, the City Clerk came forward and explained the process involved in providing Municipal Code Corporation with all the prior ordinances and resolutions adopted by the council in order to update the City's code. Chairperson Garcia opened the public hearing for discussion on this item at 8:47 p.m. Mrs. Gerri Fontanella, resident, addressed the council and voiced her concerns. No further testimony was offered and therefore Chairperson Garcia made a motion to approve the ordinance, seconded by Council member Haddad. The motion was unanimously approved by individualized voice vote. (Vote 4-0)

- 14. City Attorney's Report Informed the council that he would not be present at the next council meeting, however, Ms. Aida Martinez and Mr. J. Frost Walker, would be acting as counsel. Mr. Citrin also stated that the City is in the process of waiting for a trial date to be set on the Thunderwheels case. Mr. Walker is handling the case.
- 15. **Mayor's Report Miscellaneous –** Noted that he had established a new program through the City's Fast Ball Academy which will provide two scholarships a year for baseball players to attend different colleges throughout the U.S. The Mayor commented on his ongoing efforts for the construction of a baseball stadium at Westland Gardens Park and his progress in talking to the University of Miami to play three games a year at the park. Mayor De La Cruz also mentioned the new City run swimming program and the commencement of construction on the new recreation/office building at Westland Gardens Park.

16. Council Members Concerns/Reports – Miscellaneous

Council member Haddad – Expressed his concern of the right of way dedication for N.W. 133 Street, between N.W. 99th and 102nd Avenues. Mr. Joe Lopez, Director of Public Works, came forward and briefly addressed the issue and the progress to date.

He also voiced his concern for the illegal parking on N.W. 107 th Avenue around Westland Gardens Park and the Estates area. Lt. Van Toth came forward and stated that the "No Parking" signs had been ordered.

Council member Valdes – Requested the status of the meeting with D.E.R.M. regarding the vacant lot on N.W. 135th Street. Mayor De La Cruz explained the particulars of the meeting with D.E.R.M. and provided a letter mailed to Mr. and Mrs. Sergio Menendez stating the City's position on the issue. Mr. and Mrs. Menendez came forward and voiced their concerns on the matter. Chairperson Garcia suggested that Mr. and Mrs. Menendez contact D.E.R.M. and have something put in writing from them to prevent any further inconsistencies with their department's requirements for the clean up of the lot. Council member Valdes also inquired as to the Fourth of July event. Mayor De La Cruz gave a brief summary of the festivities planned.

Chairperson Garcia - Provided a letter from J.C. Alvarez's counsel regarding the development of the 30 acres.

Council member Zardon – No comments.
