CITY COUNCIL MEETING TUESDAY, JULY 16, 2002

CIT HALL COUNCIL CHAMBERS 10001 N.W. 87 AVENUE

- 1. **Call to Order:** Council member Rolando Piña, serving as Chairman, called the meeting to order at 7:40 p.m.
- 2. **Roll Call:** Present were Council members Rolando Piña, Lucy Valdes, Manuel Zardon and Miguel Haddad. Also present was City Attorney Charles A. Citrin.
- 3. **Invocation:** Council member Valdes gave the invocation.
- 4. **Pledge of Allegiance:** Chairperson Piña led the Pledge of Allegiance.
- 5. **Deletions/Emergency Additions:** Opening of submitted information packages for Sanitary Sewer System Evaluation and Rehabilitation (Consulting Engineering Services for Water and Sewer Department by Mr. Albert Nielson, Director Water and Sewer Department was added to the agenda as **Item 7a.**
- 6. **Review of Minutes: July 2, 2002:** Chairperson Piña made a motion to approve the minutes of July 2, 200, seconded by Council member Zardon. The motion was approved unanimously by voice vote.
- 7. Motion to reconsider the following ordinance for Public Hearing and Second reading: Council member Piña.

ORDINANCE OF THE CITY OF HIALEAH GARDENS, FLORIDA, APPROVING MIGUEL HADDAD – WAIVER OF PLAT. LEGAL DESCRIPTION: THE EAST_OF THE WEST_OF TRACT 6, OF FLORIDA FRUIT LAND COMPANY'S SUBDIVISION NO. 1, IN SECTION 29, TOWNSHIP 52 SOUTH, RANGE 40 EAST, ACCORDING TO THE PLAT THEREOF, AS RECORDED

IN PLAT BOOK 2, AT PAGE 17 OF THE PUBLIC RECORDS OF MIAMI DADE COUNTY, FLORIDA, LESS THE NORTH 30 FEET FOR ROAD RIGHT OF WAY. FOLIO #27-2029-001-0061. PROVIDING FOR CONDITIONS; PROVIDING FOR EFFECTIVE DATE. (Location: N.W. 133rd Street and East of 102nd Avenue) (P&Z 3-0 T.R.C. 4-0)

Chairperson Piña made a motion to reconsider the ordinance, seconded by Council member Valdes. The public hearing was opened at 7:44 p.m. The following individuals gave testimony on the item:

As no further testimony was offered the public hearing was closed at 7:47 p.m. and at this time Chairperson Piña made a motion to approve, seconded by Council member Valdes. Council member Zardon voted in favor with Council member Haddad recusing himself from voting. The motion passed. (Vote 3-0).

- 7a. Opening of submitted information packages for Sanitary Sewer System Evaluation and Rehabilitation Bid LO1#2002-01(Consulting Engineering Services for Water and Sewer Department: Mr. Albert Nielson, Director, Water and Sewer Department. Proposals were received from the following: CSA Group, Hazan and Sawyer, URS Corp., C3TS Corp., CES Consulting Engineering Services. Criteria for a rating system will be developed and the proposals will be reviewed by Mr. Nielson for his recommendation.
- 8. Request for Council approval of line item changes to existing budget: Mr. Marcos Piloto, Director, O.M.B., came forward and gave a brief explanation of the request to transfer \$40,000 from the Comprehensive Planning budget line item 515650 (Construction in Progress) to the Legal Counsel budget line item 514340. The transfer will cover anticipated expenses associated with legal fees involving the employee union negotiations and other outstanding litigation. Chairperson Piña made a motion to approve, seconded by Council member Zardon. The motion was approved unanimously by voice vote.
- 9. Recommendation regarding changes within the BU district: Mrs. Mirtha Gonzalez, Chief Zoning Official and Mr. Charles A. Citrin, City Attorney. Mrs. Gonzalez addressed the council and gave her recommendation to amend the uses within the BU District in order to establish a more uniform criteria for future zoning applications. A motion to draft an ordinance reflecting the discussed amendments was made by Chairperson Piña and seconded by Council member Zardon. Council member Valdes voted in favor with Council member Haddad voting against. The motion was approved. (Vote 3-1).

10. **Discussion of deposit to City of Hialeah Gardens by Mr. Miguel Haddad:** Mr. Ralph Ventura, Esq. (Tabled Item) A motion was made by Council member Haddad to table this item, seconded by Council member Valdes. The motion was approved unanimously by voice vote.

As no further testimony was offered, Chairperson Piña closed the public hearing at 8:20 p.m. He then made a motion to approve, seconded by Council member Valdes. The motion was unanimously approved by individualized voice vote. (Vote 4-0).

B) ORDINANCE OF THE MAYOR AND THE CITY COUNCIL OF HIALEAH GARDENS, FLORIDA, AUTHORIZING THE ISSUANCE OF ITS REFUNDING NOTE, SERIES 2002, IN AN AGGREGATE PRINCIPAL AMOUNT NOT TO EXCEED \$335,000.00 TO REFINANCE EXISTING OBLIGATIONS PAYABLE TO UNION PLANTERS BANK AND MIAMI DADE COUNTY RESPECTIVELY, AND COSTS RELATED THERETO; COVENANTING TO BUDGET AND APPROPRIATE FUNDS, FROM LEGALLY AVAILABLE NON-AD VALOREM REVENUES, TO REPAY SUCH NOTE; PRESCRIBING THE FORM, TERMS AND DETAILS OF THE NOTE, AWARDING THE NOTE TO SUNTRUST BANK BY NEGOTIATED DESIGNATING THE NOTE AS A QUALIFIED TAX-EXEMPT OBLIGATION WITHIN THE MEANING OF SECTION 265(b)(3) OF THE INTERNAL REVENUE CODE OF 1986, AS AMENDED; MAKING CERTAIN COVENANTS AND AGREEMENTS IN CONNECTION THEREWITH; REPEALING ALL ORDINANCES, PARTS OF ORDINANCES OR RESOLUTIONS IN CONFLICT HEREWITH; PROVIDING FOR SEVERABILITY; AND PROVIDING FOR AN EFFECTIVE DATE. (First Reading 3-0)

Mr. Charles A. Citrin read the full title of the ordinance into the record. Mr. Marcos Piloto, Director, O.M.B. addressed the Council and explained the merits of refinancing existing debt. Chairperson Piña opened the public hearing for discussion on the item at 8:23 p.m. The following individual gave testimony on the item: Mrs. Gerri Fontanella, 13425 N.W. 102nd Avenue, Hialeah Gardens, FL. As no further testimony was offered, Chairperson Piña closed the public hearing at 8:30 p.m. He then made a motion to approve, seconded by Council member Zardon. Council member Valdes

voted in favor with Council member Haddad voting against. The motion was approved. (Vote 3-1). Mr. Piloto also took this opportunity to briefly discuss the Truth in Millage (T.RI.M.) time table with the council.
