CITY OF HIALEAH GARDENS TUESDAY, June 16, 2020 CITY COUNCIL CHAMBERS 10001 NW 87 AVENUE

- **1. Call to Order:** Councilman Jorge Gutierrez, serving as Chair, called the meeting to order at 7:31 p.m.
- 2. Roll Call: Present were Councilman Jorge Gutierrez serving as Chair, Councilman Elmo Urra, Councilman Jorge Merida, Deputy City Attorney Aida Martinez-Ruiz, and Mayor Yioset De La Cruz. Councilman Rolando Piña and Chairman Luciano Garcia were absent.
- **3. Invocation:** Chairman Gutierrez gave the invocation.
- **4. Pledge of Allegiance:** Mayor Yioset De La Cruz led the led the pledge of allegiance.
- 5. Deletions/Emergency Additions: N/A
- **6. Review of Minutes: June 2, 2020** Chairman Gutierrez made a motion to approve the minutes of June 2, 2020, seconded by Councilman Merida. The motion was unanimously approved.
- **7. Public Comments:** None were offered.

8. Proposed Resolutions:

A) RESOLUTION OF THE CITY OF HIALEAH GARDENS, FLORIDA, URGING MIAMI-DADE COUNTY MAYOR CARLOS A. GIMENEZ AND THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-COUNTY, FLORIDA ("BOARD OF COMMISSIONERS") TO TRANSFER CORONAVIRUS AID, RELIEF, AND ECONOMIC SECURITY ACT (CARES) ACT DIRECT FEDERAL FUNDS RECEIVED BY MIAMI-DADE COUNTY ("COUNTY") TO THE CITY OF HIALEAH GARDENS ("CITY") AND TO OTHER UNITS OF LOCAL GOVERNMENT WITHIN THE COUNTY BASED ON POPULATION AND RATES OF COVID-19 CASES; FURTHER DIRECTING THE CITY CLERK TO TRANSMIT A COPY OF THIS RESOLUTION TO THE OFFICIALS NAMED HEREIN.

Deputy City Attorney Aida Martinez-Ruiz read the item into the record. The Mayor explained that this is the money that came from the federal government to support the County's budget during the COVID-19 crisis. The City is asking the County to release those funds individually to all Dade County municipalities. Chairman Gutierrez made a motion to approve the item, seconded by Councilman Merida. The item was approved unanimously. (3-0)

B) RESOLUTION OF THE CITY OF HIALEAH GARDENS, FLORIDA, URGING THE SOUTH FLORIDA WATER MANAGEMENT DISTRICT (SFWMD) TO TAKE IMMEDIATE ACTION TO ADDRESS THE FLOODING DISASTER THAT TOOK PLACE IN MIAMI-DADE COUNTY OVER THE PAST FEW WEEKS AND TO IMMEDIATELY ISSUE A REPORT THAT EXPLAINS IN DETAIL THE ACTIONS THAT THE SFWMD TOOK IN ANTICIPATION OF THE FLOODING DISASTER.

Deputy City Attorney Aida Martinez-Ruiz read the item into the record. The Mayor explained that this resolution is piggybacking on Commissioner Pepe Diaz's resolution. Most municipalities in Miami-Dade were affected by flooding due to heavy rains during the month of May. Canals overflowed more than they should have; this resolution is asking the SFWMD to provide a report explaining why this happened and how it will be managed in the future. Chairman Gutierrez made a motion to approve the item, seconded by Councilman Merida. The item was approved unanimously. (3-0)

C) RESOLUTION OF THE CITY OF HIALEAH GARDENS, FLORIDA, REGARDING THE APPROVAL OF A UNITY OF TITLE AGREEMENT CONCERNING PARCEL DESCRIBED ON "EXHIBIT A"; PROVIDING FOR AN EFFECTIVE DATE.

Deputy City Attorney Aida Martinez-Ruiz read the item into the record. Ms. Alessandria San Roman and her colleague Mr. Jeff Goldstein of Holland & Knight came forward on behalf of the applicant; they are seeking approval of the unity of title. They are still working out the legal details of the principal. This unity of title encompasses two parcels. This is part of the Hialeah Gardens Commerce Center project. Ms. Martinez-Ruiz explained that the lawyers have been working with Mr. Walker. If approved, the Council would be approving it on first reading with the knowledge that the signature page may change before final Council action. Chairman Gutierrez made a motion to approve the item, seconded by Councilman Merida. The item was approved unanimously. (3-0)

D) RESOLUTION OF THE CITY OF HIALEAH GARDENS, FLORIDA, AUTHORIZING THE PURCHASE OF PLAYGROUND EQUIPMENT FOR BERNIE WILSON PARK; WAIVING COMPETITIVE BIDDING UTILIZING AN EXISTING GOVERNMENT CONTRACT AS ALLOWED BY SECTION 46-119 OF THE HIALEAH GARDENS CODE OF ORDINANCES; USING THE EXISTING NATIONAL JOINT POWERS ALLIANCE CONTRACT WHICH HAD USED THE COMPETITIVE BIDDING PROCESS; AUTHORIZING THE APPROPRIATE CITY OFFICIALS TO EXECUTE AN AGREEMENT WITH MIRACLE RECREATION EQUIPMENT, CO; PROVIDING FOR CONFLICTS; PROVIDING FOR SEVERABILITY; AND PROVIDING FOR AN EFFECTIVE DATE.

Deputy City Attorney Aida Martinez-Ruiz read the item into the record. Mr. Joe Lopez, Public Works Director, came forward. Mr. Lopez read his recommendation for approval into the record. He explained that the Department is requesting Council approval for the purchase of playground equipment for the Bernie Wilson replacement park located at NW 130th Street and NW 97th Court. The equipment is listed in detail on the attached plans, renderings and quote which includes equipment and activity areas designed for handicapped children. In conjunction with Parks and Recreation the PW Department requested pricing from Miracle Recreation, Inc. for equipment and installation under an existing contract using the City's membership ID. The Department requests that the Council waive competitive bidding and allow the use of the NJPA Contract for a cost of purchase set at \$206,125.40. Chairman Gutierrez made a motion to approve the item, seconded by Councilman Merida. The item was approved unanimously. (3-0)

E) RESOLUTION OF THE CITY OF HIALEAH GARDENS, FLORIDA, AUTHORIZING THE AWARD OF A CONTRACT FOR POLICE STATION OFFICE AND BATHROOM ADDITION (PW19-102); WAIVING COMPETITIVE BIDDING; AUTHORIZING THE APPROPRIATE CITY OFFICIALS TO EXECUTE AN AGREEMENT WITH ELA CONSTRUCTION; PROVIDING FOR CONFLICTS;

PROVIDING FOR SEVERABILITY; AND PROVIDING FOR AN EFFECTIVE DATE.

Deputy City Attorney Aida Martinez-Ruiz read the item into the record. Mr. Lopez came forward once again and stated that sealed bids were received for the Police Station office and bathroom addition for furnishing all labor, materials and equipment. The bids were opened at a regular Council meeting on January 21, 2020 and contractor names and amounts were read into the record. All bids were well over the preconstruction budget of \$200,000. None of the contractors could offer the City a lower. Public Works staff then contacted ELA Construction who completed City Hall in 2008 and established a good rapport with the City. The job was quoted at \$240,000 with no reduction in finishes or materials. The funding for the project is made available through a \$150,000 GOB grant which may be lost if not spent by October 2020—and that is the reason they were not able to re-bid. The remaining funding of \$90,000 comes from the City's general fund. Mr. Lopez summarized his recommendation for approval. Ms. Martinez-Ruiz reiterated that Mr. Lopez did go back to the original bidders to see if they were willing to lower their price; those bidders did not show any interest in lowering their price. Chairman Gutierrez made a motion to approve the item, seconded by Councilman Merida. The item was approved unanimously. (3-0)
