### **MINUTES**

CITY OF HIALEAH GARDENS TUESDAY, December 1, 2020 CITY COUNCIL CHAMBERS 10001 NW 87 AVENUE

- **1. Call to Order:** Councilman Rolando Piña, serving as Chairman, called the meeting to order at 7:32 p.m.
- **2. Roll Call:** Present were Councilman Elmo Urra, Councilman Jorge Merida, Councilman Rolando Piña, Councilman Jorge Gutierrez, Deputy City Attorney Aida Martinez-Ruiz and Mayor Yioset De La Cruz. Councilman Luciano Garcia was absent.
- **3. Invocation:** Councilman Gutierrez gave the invocation.
- **4. Pledge of Allegiance:** Mayor De La Cruz led the pledge of allegiance.
- **5. Deletions/Emergency Additions:** N/A
- **6. Review of Minutes: November 17, 2020** Chairman Piña made a motion to approve the minutes of November 17, 2020, seconded by Councilman Merida. The motion was unanimously approved.
- **7. Public Comments:** None were offered.

# 8. Proposed Resolutions:

A) RESOLUTION OF THE CITY OF HIALEAH GARDENS, FLORIDA AUTHORIZING THE IMPLEMENTATION AND TRAINING OF THE FLORIDA INCIDENT-BASED REPORTING SYSTEM (FIBRS) AS WELL AS A DELL POWER EDGE R440 WITH WINDOWS AND SQL LICENSING FOR THE POLICE DEPARTMENT IN THE TOTAL AMOUNT OF \$24,006.45 UTILIZING FDLE STATE GRANT FUNDS FOR THIS PURPOSE; AUTHORIZING THE APPROPRIATE CITY OFFICIALS TO PURCHASE THE FIBRS FROM USA SOFTWARE; PROVIDING FOR CONFLICTS; PROVIDING FOR SEVERABILITY; AND PROVIDING FOR AN EFFECTIVE DATE.

Ms. Aida Martinez-Ruiz read the item into the record. She explained that Captain Douglas Zamora with HGPD had asked her to present this resolution to the Council. This is a new mandate by the FBI and Florida Department of Law Enforcement to receive uniform crime reports that will allow them to be better informed of criminal activities under local agencies. Since this was a mandate by these agencies, the FBI and FDLE have provided the grant monies for the entire implementation of the UCR program. Chairman Piña made a motion to approve the resolution, seconded by Councilman Merida. The resolution was approved unanimously. (4-0)

B) RESOLUTION OF THE CITY OF HIALEAH GARDENS, FLORIDA AUTHORIZING THE ENTERING INTO AN AGREEMENT WITH H & R PAVING FOR SERVICES RELATING TO MILLING, PAVING, STRIPPING, ROCK-BASE, AND OTHER POSSIBLE SERVICES THAT THE CITY MAY NEED IN ORDER TO MAINTAIN THE CITY ROADWAYS; WAIVING COMPETITIVE BIDDING; UTILIZING AN **EXISTING GOVERNMENT** CONTRACT AS ALLOWED BY SECTION 46-119 OF THE HIALEAH GARDENS CODE OF ORDINANCES; AUTHORIZING THE APPROPRIATE CITY OFFICIALS TO EXECUTE AN AGREEMENT WITH H & R PAVING; PROVIDING FOR CONFLICTS: PROVIDING FOR SEVERABILITY; AND PROVIDING FOR AN EFFECTIVE DATE.

Ms. Aida Martinez-Ruiz read the item into the record. Mr. Joe Lopez, Public Works Director, came forward. He explained that to continue providing the necessary maintenance and repairs to City roadways, the PW Department is requesting Council approval to contract with H&R Paving, the vendor awarded the FDOT contract number E6L74 for services related to milling, paving, striping, rock base, sub base etc. Mr. Lopez read the rest of his memo for recommendation into the record, mentioning how the Department compared prices and other offers to that of H&R Paving. The intent is to resurface old dilapidated roadways—they are going to mill and repave these areas. H&R Paving has been working on nearby 87<sup>th</sup> Avenue [in

Hialeah]. Funding source is CITT. Chairman Piña questioned the quality of the company's work and the low rates...Mr. Lopez assured him that the Department will be supervising the work...the reason the savings are significant is because H&R owns their own asphalt plant. No further questions. Chairman Piña made a motion to approve the resolution, seconded by Councilman Merida. The resolution was approved unanimously. **(4-0)**

Ms. Aida Martinez-Ruiz read the item into the record. She explained that during the last Planning and Zoning Board meeting they failed to have a quorum present; one member participated in the meeting by phone, however the Governor has since rescinded that as an unacceptable substitute for official quorum. Because the P&Z Board is only a recommending board, Ms. Martinez-Ruiz and Mr. Charles Citrin decided to allow these items to move forward as an intended recommendation of the Board and will not count as an official vote. No questions or comments from the Council. This is a first reading; an opportunity for public input will be afforded upon second reading. Chairman Piña made a motion to approve the ordinance upon first reading, seconded by Councilman Merida. The ordinance was approved unanimously by individualized voice vote. (4-0)
