### **MINUTES**

CITY OF HIALEAH GARDENS TUESDAY, February 5, 2021 CITY COUNCIL CHAMBERS 10001 NW 87 AVENUE

- **1. Call to Order:** Chairman Luciano Garcia called the meeting to order at 7:30 p.m.
- **2. Roll Call:** Present were Chairman Luciano Garcia, Councilman Elmo Urra, Councilman Rolando Piña, Councilman Jorge Merida, Deputy City Attorney Aida Martinez-Ruiz, and Mayor Yioset De La Cruz. Councilman Jorge Gutierrez was absent.
- **3. Invocation:** Chairman Garcia gave the invocation.
- 4. Pledge of Allegiance: Mayor De La Cruz led the pledge of allegiance.
- **5. Deletions/Emergency Additions:** N/A
- **6. Review of Minutes: January 5, 2021** Chairman Garcia made a motion to approve the minutes of January 5, 2021, seconded by Councilman Merida. The motion was unanimously approved.
- **7. Public Comments:** None were offered.

## 8. Proposed Resolution:

A) RESOLUTION OF THE MAYOR AND THE CITY COUNCIL (THE "COUNCIL") OF THE CITY OF HIALEAH GARDENS, FLORIDA (THE "CITY"), AMENDING AND SUPPLEMENTING RESOLUTION NO. 2446 ADOPTED BY THE COUNCIL ON AUGUST 16, 2011, TO PROVIDE FOR AN INTEREST RATE ADJUSTMENT AND A MODIFICATION OF THE PRINCIPAL AND INTEREST AMORTIZATION SCHEDULE (THE "MODIFICATION") OF THE OUTSTANDING CITY OF HIALEAH GARDENS, FLORIDA SPECIAL ASSESSMENT IMPROVEMENT BOND, SERIES 2011 (THE "SERIES 2011 BOND") ISSUED PURSUANT TO THAT CERTAIN LOAN AGREEMENT DATED AUGUST 29, 2011 (THE "LOAN AGREEMENT") BY AND BETWEEN THE CITY AND REGIONS BANK (THE "BANK") EVIDENCED BY THE SERIES 2011 BOND; AUTHORIZING SUCH MODIFICATION AND APPROVING THE FORM OF AND AUTHORIZING THE EXECUTION AND DELIVERY OF A FIRST AMENDMENT TO LOAN AGREEMENT AND BOND MODIFICATION AGREEMENT: PROVIDING FOR CERTAIN OTHER MATTERS IN CONNECTION THEREWITH; AUTHORIZING THE PROPER OFFICIALS OF THE CITY TO DO ALL ACTS NECESSARY AND PROPER FOR CARRYING OUT THE TRANSACTIONS CONTEMPLATED BY THIS PROVIDING RESOLUTION; FOR SEVERABILITY; AND PROVIDING FOR AN EFFECTIVE DATE.

Ms. Martinez-Ruiz read the item into the record. Mr. Juan Rivera, Finance Director, came forward to explain the purpose of this resolution. During fiscal year 2018-2019, the City received pre-payments from several property owners. The City should have decreased the principal by the amount of pre-payments that they received. Since they didn't, Mr. Rivera met with the bank and they mutually agreed on terms to refinance this loan. The City also agreed to make a one-time pre-payment of \$370,550 this fiscal year. The interest rate is still the same: 4.45%. Mr. Rivera confirmed that the loan monies will come from the general fund. Everything is already transferred and accounted for.

No further questions or comments. Chairman Garcia made a motion to approve the resolution, seconded by Councilman Merida. The resolution was unanimously approved. **(4-0)**
