CITY OF HIALEAH GARDENS TUESDAY, April 20, 2021 CITY COUNCIL CHAMBERS 10001 NW 87 AVENUE

- **1. Call to Order:** Chairman Luciano Garcia called the meeting to order at 7:31 p.m.
- **2. Roll Call:** Present were Chairman Luciano Garcia, Councilman Jorge Gutierrez Councilman Elmo Urra, Councilman Jorge Merida, and City Attorney Charles Citrin. Councilman Rolando Piña and Mayor Yioset De La Cruz were absent.
- **3. Invocation:** Chairman Garcia gave the invocation.
- **4. Pledge of Allegiance:** Mr. Citrin led the pledge of allegiance
- 5. Deletions/Emergency Additions: N/A
- **6. Review of Minutes: March 16, 2021** Chairman Garcia made a motion to approve the minutes of March 16, 2021, seconded by Councilman Merida. The motion was unanimously approved.
- **7. Public Comments:** None were offered.

8. Request for approval of transfer of 2 A.P.S. alcohol beverage license for Tiny's Food Store, 8004 N.W. 103 Street, Hialeah Gardens, Florida Owner: Ms. Missalys Perez.

Chairman Garcia read the item into the record. Ms. Missalys Perez came forward and stated her name and address for the record. Mr. Robert Lorenzo, Director of Business Tax Receipt, came forward and read the recommendation for approval into the record; City Staff recommends that the City Council transfer the 2 APS alcohol beverage license from the previous owners to Tiny's Food Store. No further comments. Chairman Garcia made a motion to approve the request, seconded by Councilman Merida. The item was approved unanimously.

Mr. Citrin read the item into the record. Mr. Juan Rivera, Finance Director, came forward explained the purpose of this purchase. The three vehicles are replacing three existing old vehicles in the Code Compliance and Building Department. The City is utilizing the Florida Sheriffs Bid #FSA20-VEL28.0 for this purchase. The price of each vehicle is \$31,255. They will be delivered within 90 days and the funds for this expenditure have been allocated in the budget. No further comments or questions. Chairman Garcia made a motion to approve the resolution, seconded by Councilman Merida. The item was approved unanimously. (4-0)

B) RESOLUTION OF THE CITY OF HIALEAH GARDENS, FLORIDA AUTHORIZING THE PURCHASE OF ONE (1) 2021 CHEVROLET SILVERADO 4WD REGULAR CAB IN THE AMOUNT OF \$30,290.00 AND ONE (1) 2021 CHEVROLET SILVERADO 4WD CREW CAB IN THE AMOUNT \$32,702.00 TO BE USED BY THE PUBLIC WORKS DEPARTMENT; WAIVING COMPETITIVE BIDDING AND USING AN EXISTING GOVERNMENT CONTRACT AS ALLOWED BY ORDINANCE 2002-54; AUTHORIZING THE APPROPRIATE CITY OFFICIALS TO EXECUTE AN AGREEMENT WITH AUTO NATION CHEVROLET, INC. FOR A TOTAL AMOUNT

The two trucks will be added to the Public Works Department fleet. They are an expansion to the fleet, not a replacement. The cost of each car is \$30,290 and \$32,702, respectively.
