- **1. Call to Order:** Councilman Piña serving as Chairman called the meeting to order at 7:30 p.m.
- **2. Roll Call:** Present were Councilman Elmo L. Urra, Councilman Jorge Gutierrez Councilman Jorge A. Merida, Councilman Rolando Piña and City Attorney Charles A. Citrin. Councilmen Luciano Garcia and Jorge Gutierrez were absent as was Mayor Yioset De La Cruz.
- **3. Invocation:** City Attorney Charles Citrin gave the invocation.
- 4. Pledge of Allegiance: Chairman Piña led the Pledge of Allegiance.
- 5. Deletions/Emergency Additions: N/A
- **6. Review of Minutes: May 3, 2022** Chairman Piña made a motion to approve the minutes of May 3, 2022. The motion was approved unanimously.
- **7. Public Comments:** None were offered.

8. Proposed Resolution:

The recommendation was to award the contract to Construction Catering, Inc, as the City has been working with this company for many years and the cost amounts for the meals have remained the same for over four years. Chairman Piña asked if the participants are happy with the quality and quantity of the meals, to which Ms. Morales responded that they were in fact pleased with current nutrition program.
