CITY OF HIALEAH GARDENS TUESDAY, June 7, 2022 CITY COUNCIL CHAMBERS 10001 NW 87 AVENUE

- **1. Call to Order:** Chairman Luciano Garcia called the meeting to order at 7:30 p.m.
- 2. **Roll Call:** Present were Chairman Garcia, Councilman Elmo L. Urra, Councilman Jorge Gutierrez and Councilman Jorge A. Merida. Mayor Yioset De La Cruz and Deputy City Aida Martinez-Ruiz were also present. Councilman Rolando Piña was absent.
- **3. Invocation:** Chairman Garcia gave the invocation.
- **4. Pledge of Allegiance:** Mayor De La Cruz led the Pledge of Allegiance.
- **5. Deletions/Emergency Additions:** N/A
- **6. Review of Minutes: May 17, 2022** Chairman Garcia made a motion to approve the minutes of May 17, 2022. The motion was approved unanimously.
- **7. Public Comments:** None were offered.

8. First Reading for consideration of the following ordinances:

A) ORDINANCE OF THE CITY COUNCIL OF THE CITY OF HIALEAH GARDENS, FLORIDA, AUTHORIZING THE ENTERING INTO A LEASE AGREEMENT WITH LEASING 2 IN AN AMOUNT NOT TO EXCEED THREE HUNDRED AND SIXTY THOUSAND ONE HUNDRED AND FOURTEEN DOLLARS AND FORTY FIVE CENTS (\$360,114.45) FOR THE PURPOSE OF PURCHASING A TYMCO 600 SWEEPER FOR THE PUBLIC WORKS DEPARTMENT; AWARDING THE LEASE AGREEMENT TO LEASING 2; MAKING CERTAIN COVENANTS AND AGREEMENTS IN CONNECTION THEREWITH; **PROVIDING** FOR THE **ADOPTION** REPRESENTATIONS: **PROVIDING** FOR SEVERABILITY; PROVIDING FOR CONFLICTS; PROVIDING FOR AN EFFECTIVE DATE.

Ms. Martinez-Ruiz read the item into the record. Chairman Garcia stated that this is a first reading and as such an opportunity for public input would be afforded upon second reading. At this time Ms. Martinez-Ruiz added that this ordinance is needed as the City will be incurring debt. A resolution for the purchase of the equipment will also be prepared for the next Council meeting when the second reading will occur for this financing ordinance. The Chair made a motion to approve the item, seconded by Councilman Merida. The ordinance was approved unanimously by individualized voice vote. (4-0)

B) ORDINANCE OF THE CITY OF HIALEAH GARDENS, FLORIDA, SAFEGUARDING THE WELFARE OF RESIDENTS BUSINESSES OF THE CITY FROM SOIL EROSION BY GUIDING, REGULATING, AND CONTROLLING THE DESIGN, CONSTRUCTION, USE AND **MAINTENANCE** OF ANY DEVELOPMENT OR OTHER ACTIVITY THAT DISTURBS THE TOPSOIL OR MOVEMENT OF EARTH ON LAND IN THE CITY; AMENDING THE CITY CODE; AMENDING DEFINITIONS; PROVIDING FOR INCLUSION INTO THE CODE; PROVIDING FOR SEVERABILITY; PROVIDING FOR CODIFICATION; PROVIDING FOR AN EFFECTIVE DATE.

Ms. Martinez-Ruiz read the item into the record and mentioned that this ordinance, as the one to follow, are two ordinances that have been required of the City. She noted that Mr. Joe Lopez, Public Works Director was present if the Council would like him to provide any details. Chairman Garcia, however stated that as this is a first reading, an opportunity for Mr. Lopez's and any public input would be afforded upon second reading. The Chair made a motion to approve the item, seconded by Councilman Merida. The ordinance was approved unanimously by individualized voice vote. **(4-0)**

The Chair made a motion to approve the item, seconded by Councilman Merida. The ordinance was approved unanimously by individualized voice vote. **(4-0)**
