5. Any player who missed (3) games or (3) practices without a reasonable explanation will be removed from the team and placed in the pool. **The registration fee will not be refunded.**
6. Any player whose parents, relative or friend becomes argumentative, disruptive, or confrontational with a manager, umpire, player, spectator or any other league or park member will risk the possibility of expulsion and /or suspension from the league and the park facility.
7. Any false information given to the league may result in the player's termination from the H.G.Y.B.L. **The registration fee will not be refunded.**
8. **SPECIAL RULE: IT'S AN OBLIGATION FOR ALL PARTICIPANTS OF THE LEAGUE TO BUY (1) SLICE OF PIZZA AND (1) SODA FOR EVERY PLAYER ON THE TEAM. YOUR COACH WILL PROVIDE YOU WITH A LIST THAT WILL DETERMINE WHEN IT WILL BE YOUR TURN.**
