CITY OF HIALEAH GARDENS TUESDAY, May 21, 2024 CITY COUNCIL CHAMBERS 10001 NW 87 AVENUE

- **1. Call to Order:** Chairman Luciano Garcia called the meeting to order at 7:30 p.m.
- **2. Roll Call:** Present were Councilman Elmo Urra, Councilman Jorge Gutierrez, Councilman Jorge Merida, Councilman Rolando Piña, Chairman Luciano Garcia, Mayor Yioset De La Cruz, and Mr. Charles Citrin, serving as City Attorney.
- **3. Invocation:** Chairman Garcia gave the invocation.
- **4. Pledge of Allegiance:** Mayor De La Cruz led the Pledge of Allegiance.
- **5. Deletions/Emergency Additions:** N/A
- **6. Review of Minutes:** May 7, 2024 Chairman Garcia made a motion to approve the minutes of **May 7, 2024**. The motion was approved unanimously.
- **7. Public Comments:** None were offered.

8. Opening of sealed bids for PW-24-106 Utility Work Okeechobee Frontage Road from E. of 116 Way to E. of NW 87 Avenue: Mr. Joe Lopez, Public Works Director.

Mr. Joe Lopez, Public Works Director, came forward. The Department advertised a notice to contractors for utility work in the aforementioned area. Due to the complexity and size of the project and to ensure a competitive bid process the Department extended the opening date from today, May 21, to June 4, 2024. All registered bidders were informed of the extension and this memorandum was posted as a public notice.

9. Opening of sealed bids for PW-24-107 Utility Work NW 107 Avenue from NW 138 Street to NW 147 Street: Mr. Joe Lopez, Public Works Director.

Mr. Joe Lopez, Public Works Director, came forward once again. Two bids were submitted for this project. Mr. Lopez opened the first, from Marcdan Inc., with a bid amount is \$987,960.00. The second bid was from Acosta Tractors, Inc., with a bid amount of \$598,169.04. Mr. Lopez stated that the Department would review them and come back to the Council with a recommendation.

10. Proposed Resolutions:

Mr. Citrin read the resolution into the record. Mayor De La Cruz briefly introduced Kristopher Perez, the new Water & Sewer Director. This agreement is with Mrs. Barbara Joy, the previous Department administrator, who recently retired, and will be kept on board on a consulting basis. This is ratifying the consulting contract which will be used as needed by the Department.

At this time, Mr. Perez came forward and spoke briefly about his career history up until this point. Chairman Garcia welcome Mr. Perez to the City.

The Chair made a motion to approve the resolution, seconded by Councilman Merida. The resolution was approved unanimously. **(5-0)**
